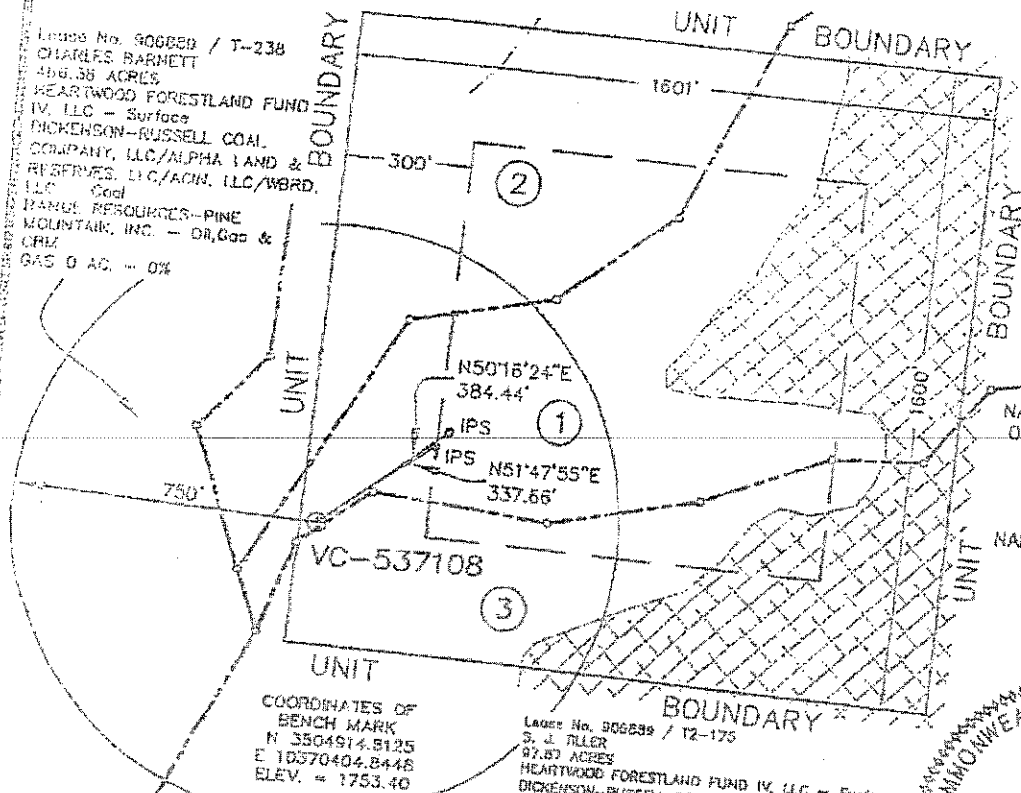

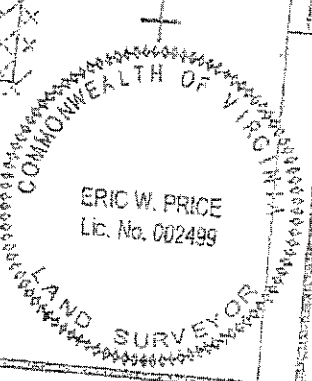

ARTICLE II: EXECUTRIX, DEBTS AND TAXES

I hereby excuse each of the persons or entities nominated herein to serve as a personal representative of my estate from the requirement of posting a fiduciary bond, and from the requirement of filing an inventory of my estate.

I hereby grant to these personal representatives of my estate all of the rights and powers set forth in Tennessee Code Annotated Section 35-50-110, as amended at the time of my death, or any successor statute in effect at the time of my death, insofar as the same pertains to the powers and duties of personal representatives of decedents' estates, and all of such rights and powers are incorporated expressly by this reference into this Last Will and Testament, except as they may be limited generally or in any particular application by the provisions elsewhere in this Last Will and Testament, or by a court of competent jurisdiction. Provided, however, that the personal representative of my estate shall not retain any asset in my estate when it is clearly in the best interest of my estate to dispose of such asset. Provided, further, that the personal representatives of my estate shall not place or invest any funds of my estate in a certificate of deposit or any account in a financial institution which is not covered completely by the deposit insurance provided by the Federal Deposit Insurance Corporation, or its successor, or a similar department, agency or corporation of the United States. The personal representatives of my estate may apply any income upon any of the assets in my estate to principal or to income, or partially to principal and partially to income, as it may in its discretion deem best. I hereby direct the personal representative of my estate to pay my just debts, the expenses of my last illness, if any, the expenses of my burial and of my funeral, including a suitable marker for my grave, and any federal and state inheritance, estate and other death taxes pertaining to my estate as soon as practicable after my death.

The personal representatives of my estate shall have any and all powers necessary to undertake the ancillary administration of my estate in any foreign states where needed, and, in the course of the administration of my estate, to liquidate any property of my estate which may be found in any foreign state.

ARTICLE V: MISCELLANEOUS PROVISIONS

1. No beneficiary shall have any right to anticipate, to pledge, to encumber or to hypothecate or in any other manner to alienate his or her interest in either the income or the principal of any testamentary gift made in trust under this Last Will and Testament, and his or her interest in the corpus and undistributed income of any such trust shall not be liable for his or her debts, contracts, or engagements, or subject to execution, attachment, sequestration or other legal process.
2. No gift made by me in this Last Will and Testament shall be deemed to be an exercise or a grant of any power of appointment.
3. No gift made by me during my lifetime shall be deemed to have been an advancement to the donee against his or her share in my estate; and therefore no gift made by me in this Last Will and Testament shall be deemed to have been adeemed by satisfaction.

4. All of my testamentary gifts in this my Last Will and Testament shall be deemed to vest immediately upon my death, and none of my testamentary gifts shall be construed to be a gift to a class of persons.

5. For the payment of my just debts, the expenses of my last illness, if any, and my burial and funeral expenses and any federal and state inheritance, estate or other death taxes pertaining to my estate, my whole estate shall be liable without apportionment against the share of any particular beneficiary of my estate, and the property in my estate shall abate in the following order: First, any intangible personal property in my estate, including any cash on hand or on deposit with any financial institution; second, any other personal property in my estate; third, any real property which I own at the time of my death, excluding any real property which I am using as a residence at the time of my death; and, fourth, the residue of my estate.
