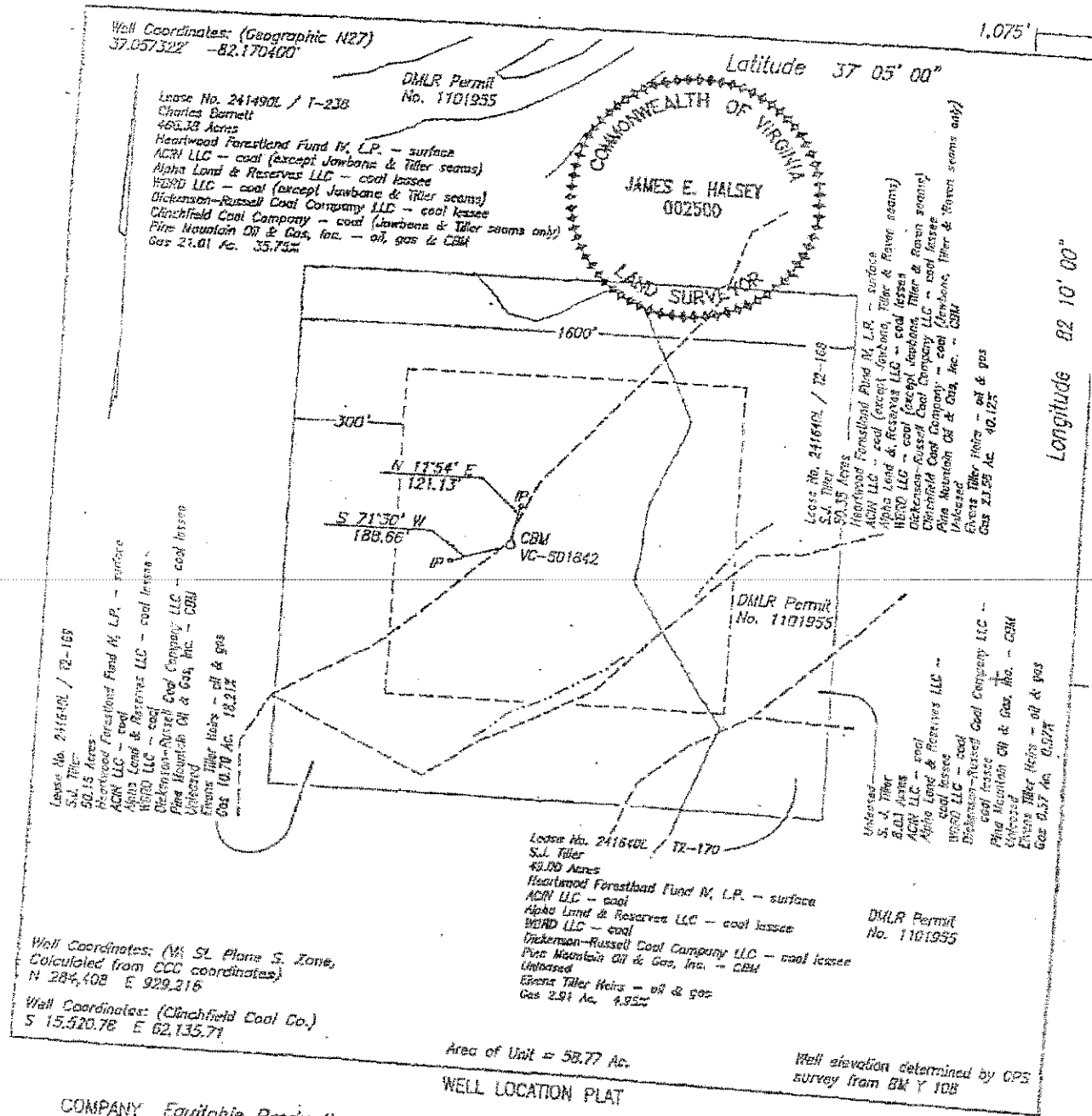

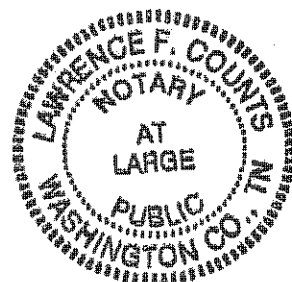

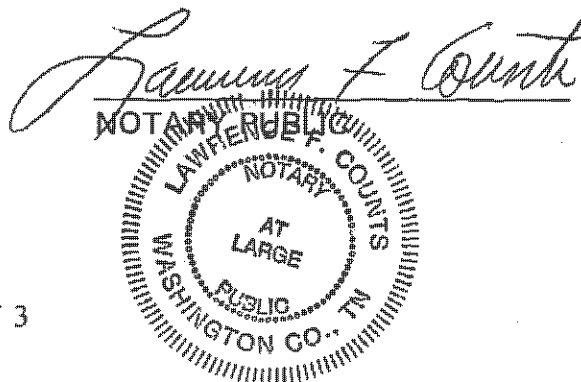

**ARTICLE I**

I hereby amend Article VI of my Last Will and Testament, which I executed on December 20, 1967, and add the following provisions:

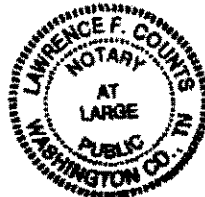



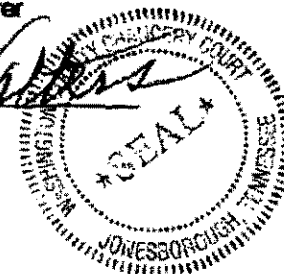
