**4. Type of Well(s)**

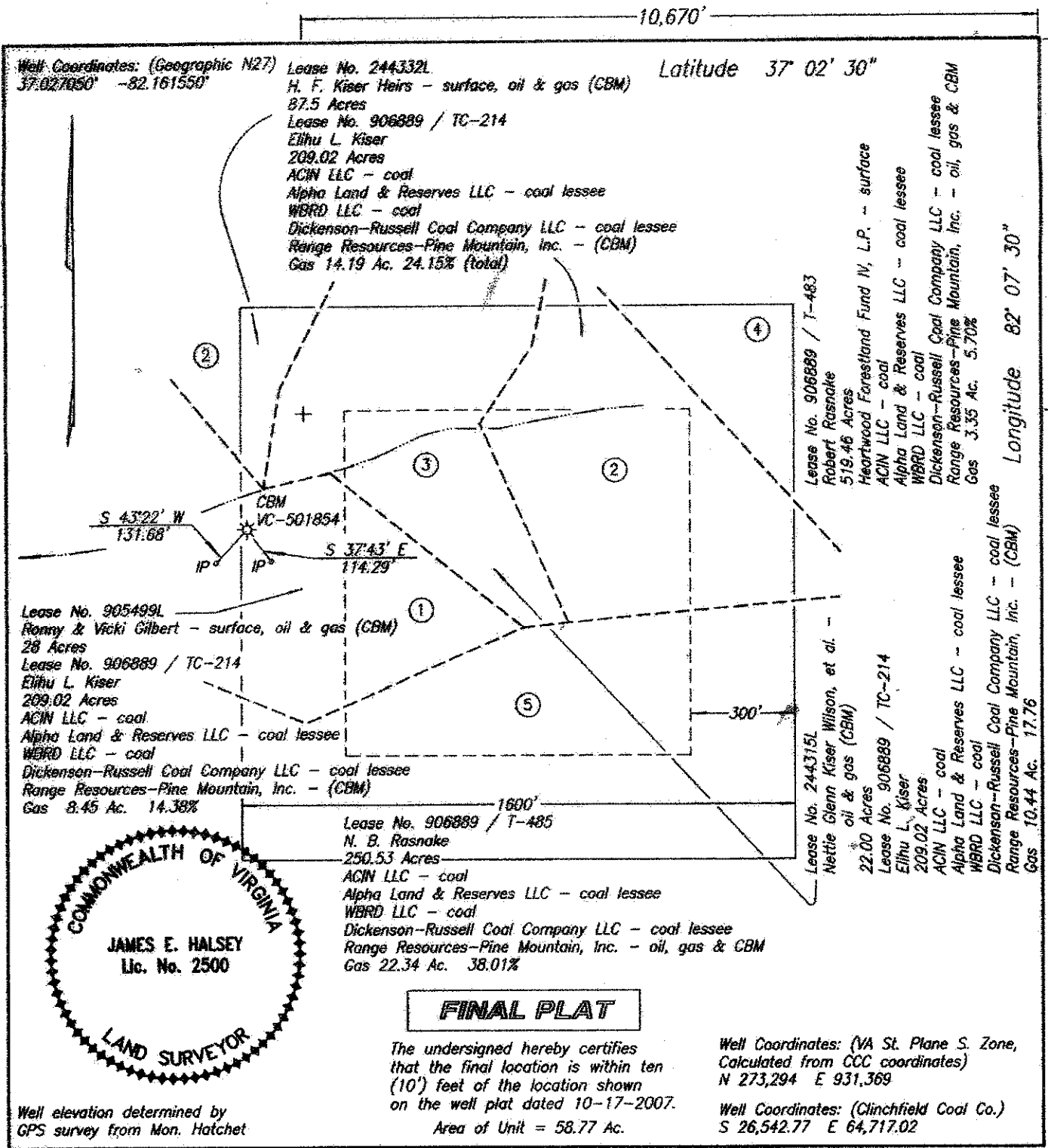

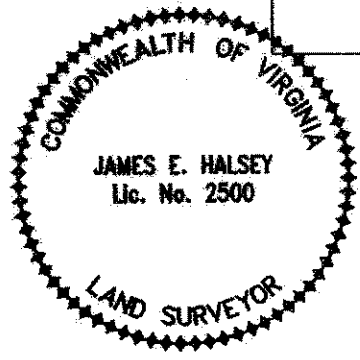

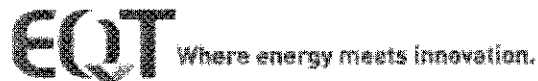
Good Morning All,

I am currently completing the disbursement exhibits for Well 501854. Payments were made into escrow for this well under Dockets 1324 (Exp) and 2102. Therefore, I am unable to reconcile based on the information that is being automatically populated on the website (the amount that is populated in the bank section only shows payments of \$6,605.00 through 12/31/2012); however, EQT has payments totaling \$14,712.72.

I believe this can be corrected by combining the two docket accounts. I have attached a spreadsheet that shows EQT's payments for this well. By comparing EQT's payments with the Escrow Agent account summary sheets that are online, I was able to reconcile payments from 05/2008 through 01/2010. These payments were made under docket 1324 and total \$7,881.60 (These are shown in green on the spreadsheet). I was also able to reconcile payments made under Docket 2102 and total \$6,588.30 (these are shown in purple on the spreadsheet).

Can you please let me know how I should proceed in providing the reconciliation (Exhibit J) information for submission?
