4. Type of Well(s)

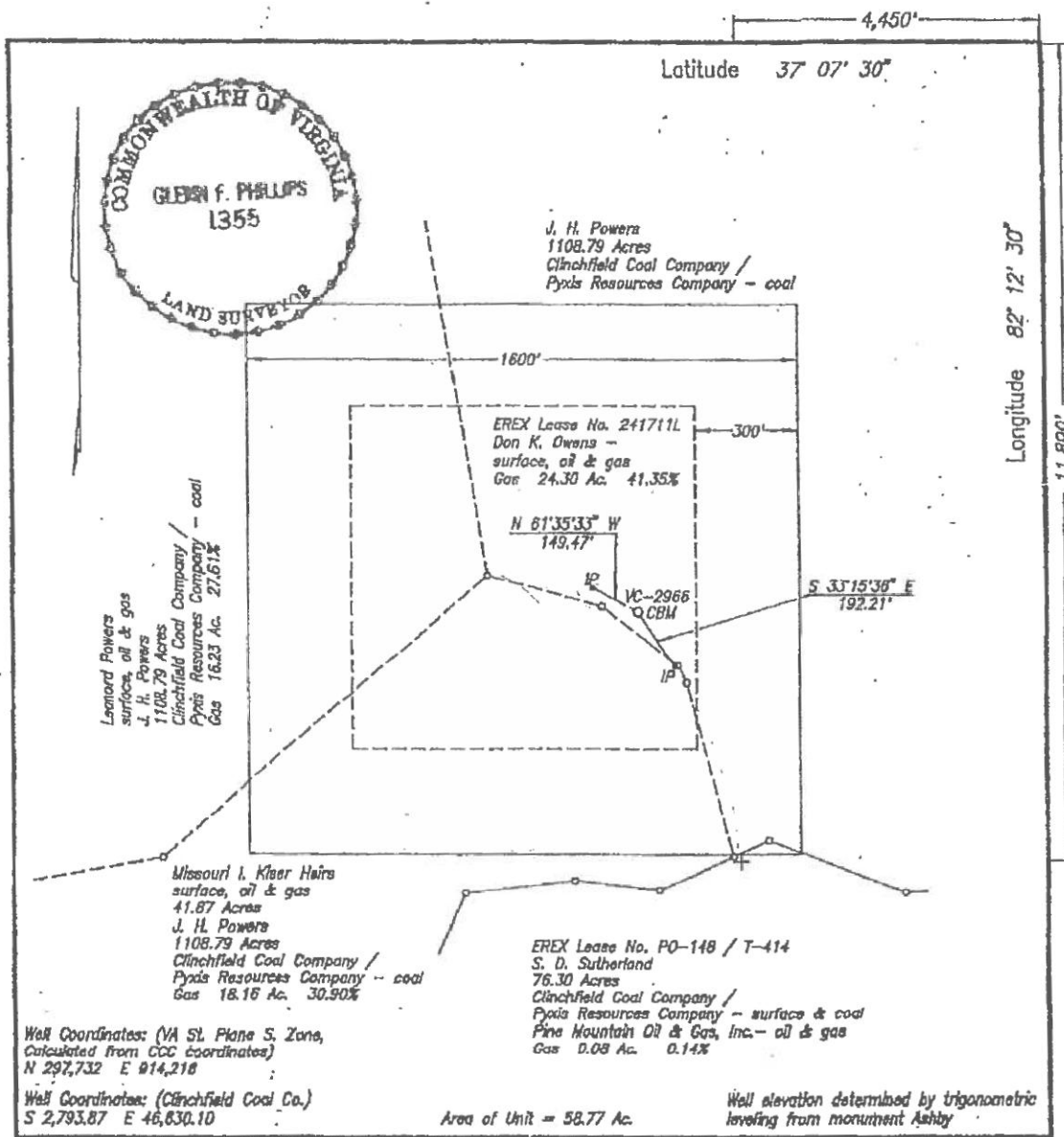
