**4. Type of Well(s)**

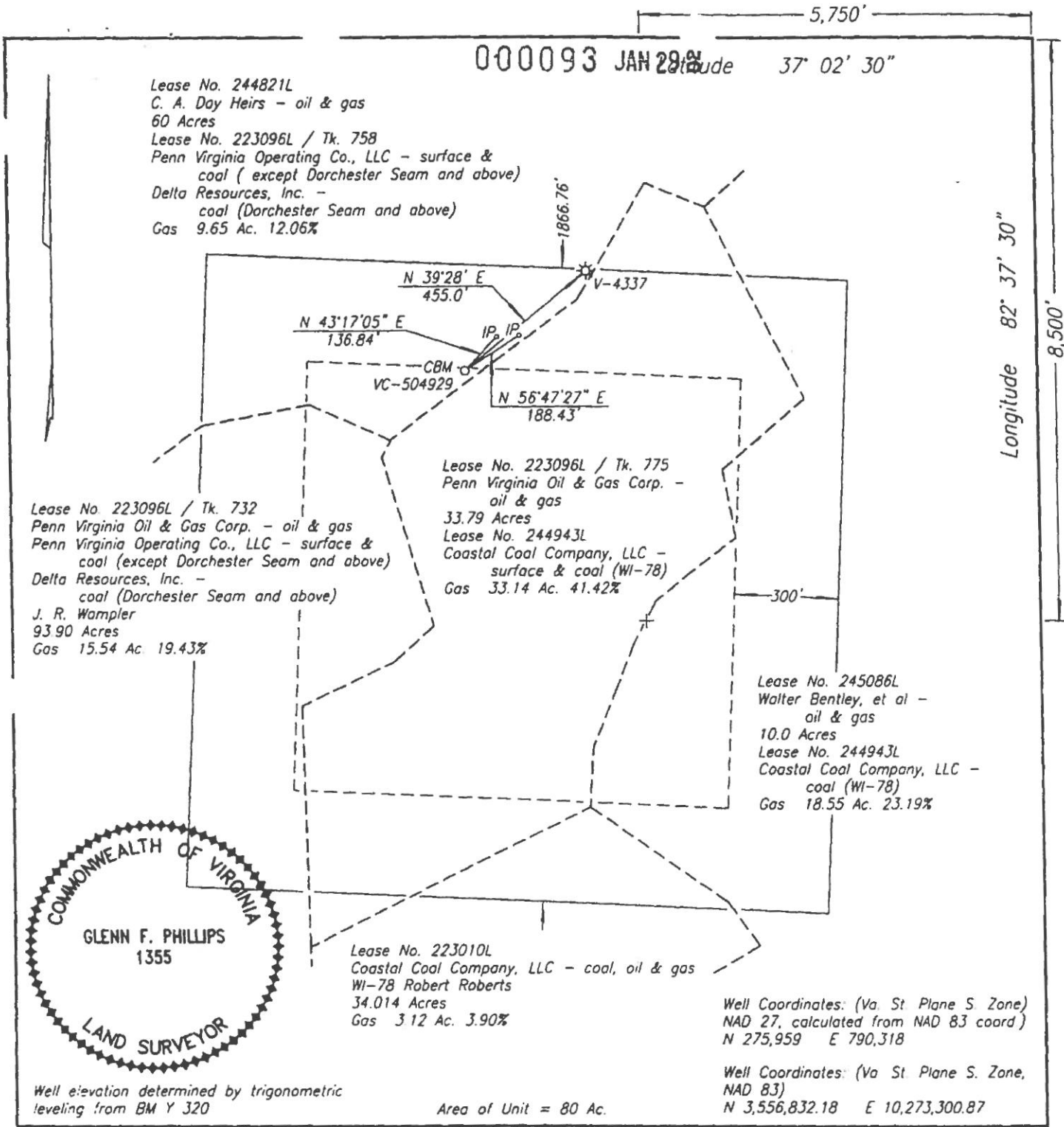


5. Nothing further remaining to be done, on motion of counsel for the plaintiff, this action is dismissed with prejudice and stricken from the Court's docket.




