**4. Type of Well(s)**

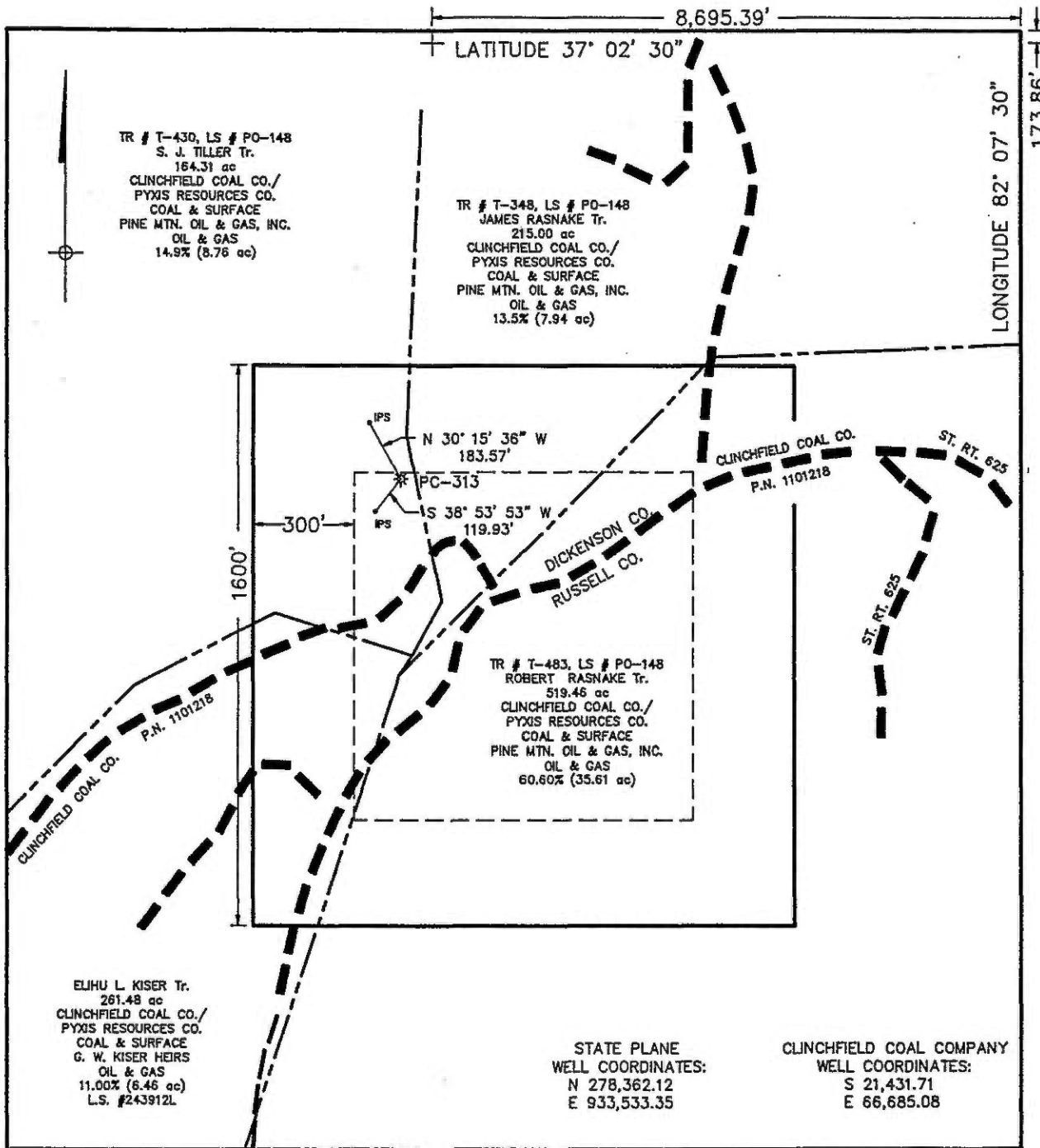

LAST WILL AND TESTAMENT

I, DIANA DOLORES KISER, of Tazewell County, Virginia, declare this to be my last will and testament, and I hereby revoke all wills and codicils heretofore made by me.

ARTICLE 1

A. I may decide to leave a written statement or list identifying a person or persons to receive one or more items of my tangible personal property which are not otherwise specifically bequeathed by this will or any codicil hereto. If I do leave such a statement or list I intend that it be given effect at my death in accordance with the provisions of Virginia Code § 64.1-45.1 (or any successor provision then in force.)

B. I bequeath the rest and residue of my tangible personal property or, if I do not leave the written statement or list referred to in Paragraph A, all of my tangible personal property to my daughters, Terri Kiser Farley and Karen Kiser Peters, in shares considered by my Executor to be approximately equal in value (taking into account any gifts made to any child by the list referred to in Paragraph A.), with the issue of ~~any~~ deceased daughter to take such child's share. However, if any beneficiary is less than eighteen (18) years of age, my Executor may

C. If any beneficiary in Article 2, or any beneficiary of a pecuniary bequest in Article 1, is under the age of eighteen (18) years (herein referred to as the age of distribution) at the time that distribution of the beneficiary's share and/or bequest is to be made to the beneficiary, then I give the share and/or bequest of such beneficiary to my Trustee, in trust, to hold, manage and expend for the benefit of the beneficiary. Taking into account all sources of income, support rights, and other

This trust shall terminate when the beneficiary reaches the age of distribution, and the trust's assets shall be paid over, delivered, and conveyed to the beneficiary.

A. The term "tangible personal property" shall be construed as not including (i) motor vehicles, (ii) boats, or (iii) any other tangible personal property that, in the determination of my Executor, is (a) held primarily for investment purposes or (b) used in connection with any
