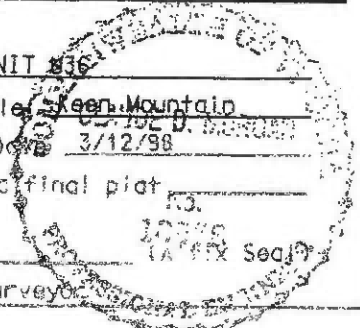
-  TRACT LAND HOOK
