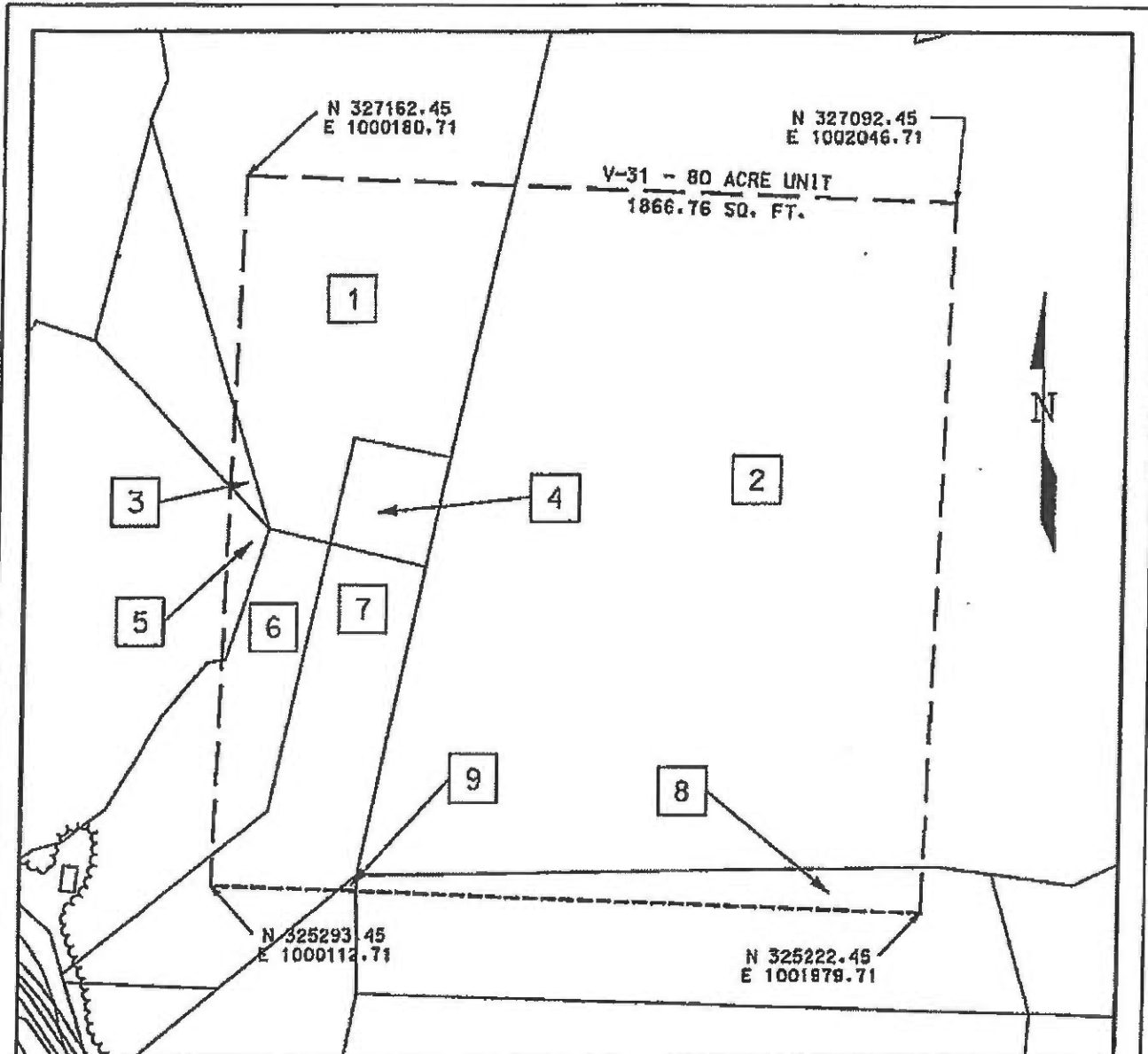

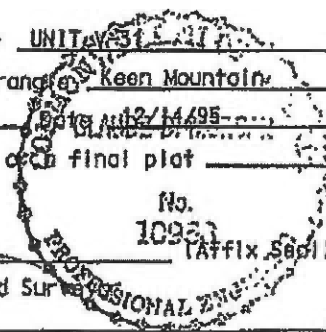
-  TRACT LAND HOOK


