Allegation of Facts: Applicant is the owner of the right to develop and produce coalbed methane gas from all of the units listed on Exhibit "G" pursuant to a Purchase and Sale Agreement effective as of January 1, 2014. The existing Unit Operator (GeoMet Operating Company, Inc.) has provided written approval of the transfer. See Exhibit "F" attached hereto and made a part hereof.

3. Legal Authority: The relief sought by this Application is authorized by Va. Code Ann. § 45.361.21 *et seq.* and § 4 VAC 25-160-120.

4. Relief Sought: Applicant requests the Virginia Gas and Oil Board to enter an order transferring the right to operate all units listed in this application that were established by Board Order, from GeoMet Operating Company, Inc. to ARP Mountaineer Production, LLC.



Dear Mr. Lambert:

GeoMet, Inc. and GeoMet Operating Company, Inc. (collectively, "GeoMet") sold all of its interests in wells and well production units it owned and operated in the Commonwealth of Virginia to ARP Mountaineer Production, LLC effective January 1, 2014. Each production unit was in Buchanan County in the Oakwood Coalbed Degasification Field. The majority of those production units were established by Board Order of the Virginia Gas and Oil Board. ARP Mountaineer Production, LLC should be recognized as the current operator under the permits and Orders. In most cases, ARP is also the sole owner of those units, but there are a few units where third parties participated in the drilling of the wells.

This letter will serve as acknowledgment and confirmation from GeoMet for all of the Board Ordered Production Units to be transferred to ARP Mountaineer Production, LLC as owner/part owner and operator of those Board Ordered Production Units. Please revise and update your records accordingly.
