2. Relief Sought

1) the disbursement of escrowed funds heretofore deposited with the Board's Escrow Agent, attributable to of Tract 2C, as depicted upon the annexed table; and (2) authorization to begin paying royalties directly to Harrison-Wyatt LLC, Betty Johnson McClanahan, Helen Johnson Faulkner, Blanche Johnson Dale, Agnes Johnson Bartee, Douglas W. Johnson, Phyllis Johnson Durland, Kathryn Johnson Webb, Lorene Coleman Lester, Peter Jacobson, John Dorsie Arms, Ruby Pauline Arms Jenkins, Ella Mae Compton Deel, Lottie Jean Mullins. Unit BB8.

3. Legal Authority

Va. Code Ann. § 45.1-361.1 et seq., 4 VAC 25-160-140., and relevant Virginia Gas and Oil Board Orders ("Board") heretofore promulgated pursuant to law.

4. Type of Well(s)

Coalbed Methane

5. Factual basis for relief requested

- a. Harrison-Wyatt, LLC. and Betty Johnson McClanahan, Kathryn Johnson Webb, John Dorie Arms, and Ruby Pauline Arms Jenkins have entered into royalty split agreement(s). Said royalty split agreement(s) allow the Applicant and Designated Operator to pay royalties directly to the persons identified in Exhibit EE.
- b. Helen Johnson Faulkner, Blanche Johnson Dale, Agnes Johnson Bartee, Douglas W. Johnson, Phyllis Johnson Durland, Lorene Coleman Lester, Peter Jacobson, Ella Mae Compton Deel, Lottie Jean Mullins are the gas claimants in Tract 2C. As such, is entitled to 100% of the CBM royalties now in escrow and as may be hereafter payable. See Va. Code Ann. § 45.1-361.22:2.A.
- c. That CNX Gas Company LLC has given the notice(s) required by § 45.1-361.22:2.A to all conflicting claimants identified in the above referenced pooling Order and any supplemental Orders pertaining thereto.
- d. That none of the conflicting claimants noticed have provided, within 45 days of the notice(s) given as provided in b. above, the Board, its designated agent the Director of the Division of Gas and Oil, the Operator and/or the Applicant evidence of either an agreement regarding the escrowed funds/royalties or a proceeding regarding same.
- e. That a detailed accounting in accordance with the applicable provisions of § 45.1-361.22 is submitted herewith and identified as Exhibit J.
- f. That an Exhibit identified as Table 1 is annexed hereto, and it specifies how the disbursement (s) is to be calculated and paid by the escrow agent.
- g. That Va. Code Ann. § 45.1-361.22:2.A. further provides that the Operator shall pay such royalties as may hereafter be payable directly to the gas claimant CNX Gas Company LLC and not escrow same. See Exhibit EE annexed hereto.

6. Attestation

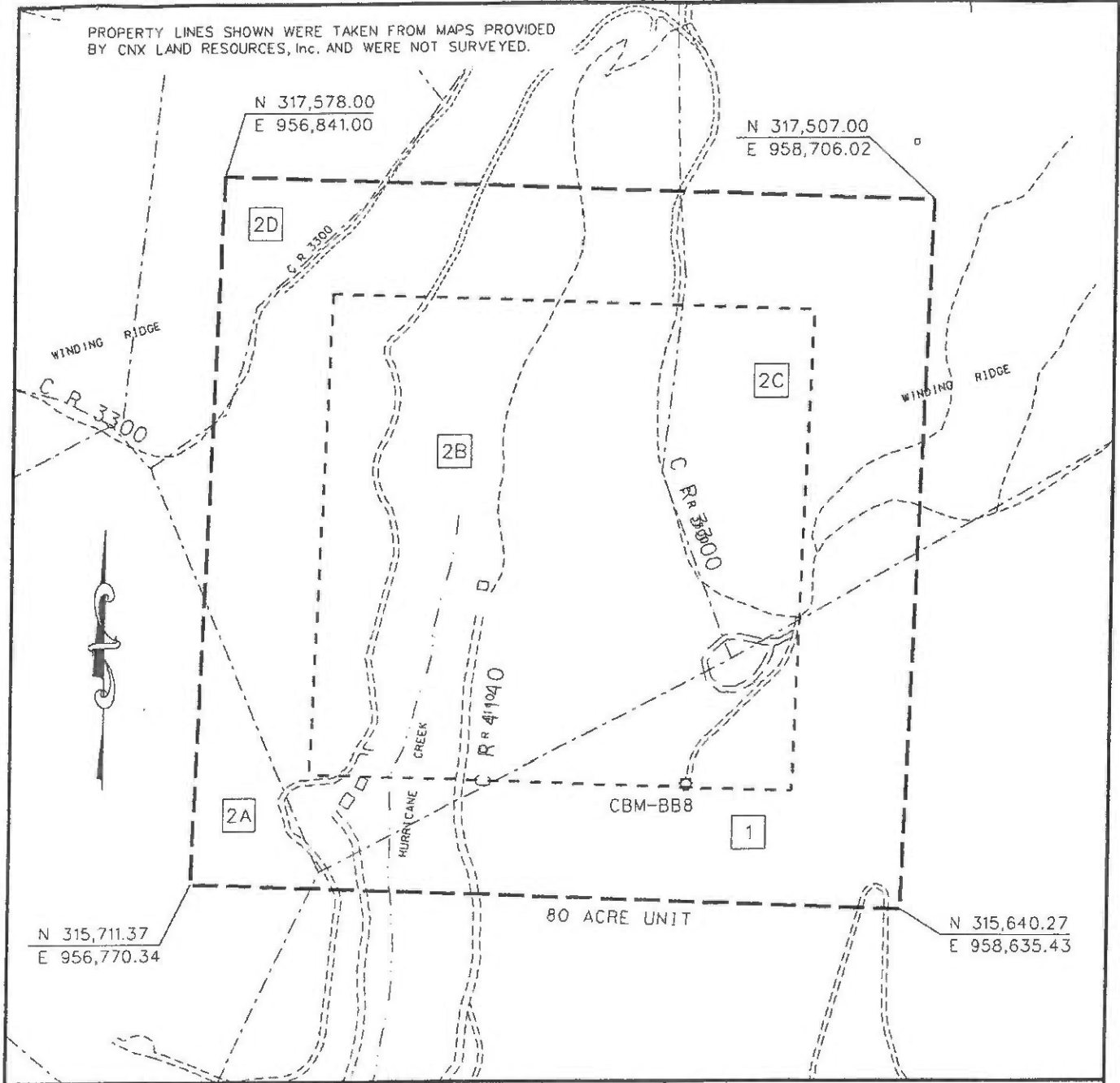




