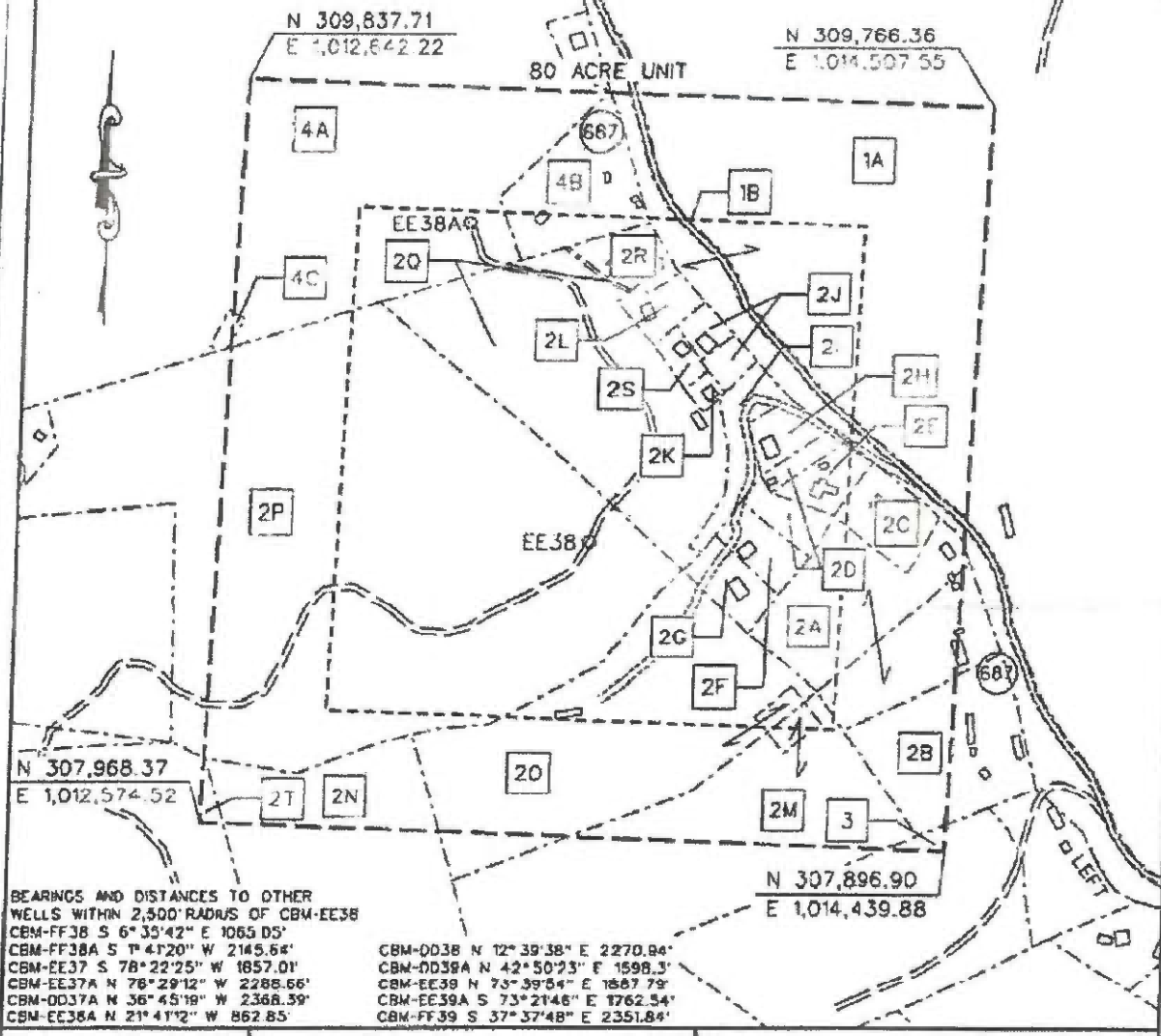
5. Factual basis for relief requested

- a. CNX Gas Company LLC, Jerry Thomas Absher, Travis Benton Absher, Joel Lewis Absher, Coy Allen Absher, Charles Wayne Absher, Larry Gale Absher, Karen Lynn Johnson, Lois Yuvon Osborn, Linda Absher, Janet B. Walker, Tammy Coleeda Absheris entitled to 100% of the CBM royalties awarded under Case No. CL11000906, Opinion dated November 9, 2011, Said decision allows the Applicant and Designated Operator to pay royalties directly to the person(s) identified in Exhibit EE annexed hereto and the annexed Table, further, specifies how said royalties are to be paid.
- b. Coal Mountain Mining Co. & David L. Cordill, Robert E. Cordill have entered into royalty agreement(s). Said royalty split agreement allows the Applicant and Designated Operator to pay royalties directly to the persons identified in Exhibit EE annexed hereto and the annexed Table, further, specifies how said royalties are to be divided and paid.
- c. Knox Creek Coal Corporation, Paul Chaney & FD Robertson are the gas claimant in Tracts 2I As such Knox Creek Coal Corporation, Paul Chaney & FD Robertson is entitled to 100% of the CBM royalties now in escrow and as may be hereafter payable. See Va. Code Ann. § 45.1-361.22:2.A.
- d. That CNX Gas Company LLC has given the notice(s) required by § 45.1-361.22:2.A to all conflicting claimants identified in the above referenced pooling Order and any supplemental Orders pertaining thereto.
- e. That none of the conflicting claimants noticed have provided, within 45 days of the notice(s) given as provided in b. above, the Board, its designated agent the Director of the Division of Gas and Oil, the Operator and/or the Applicant evidence of either an agreement regarding the escrowed funds/royalties or a proceeding regarding same.
- f. That a detailed accounting in accordance with the applicable provisions of § 45.1-361.22 is submitted herewith and identified as Exhibit J.
- g. That an Exhibit identified as Table 1 is annexed hereto, and it specifies how the disbursement (s) is to be calculated and paid by the escrow agent.
- h. That Va. Code Ann. § 45.1-361.22:2.A. further provides that the Operator shall pay such royalties as may hereafter be payable directly to the gas claimant Knox Creek Coal Corporation, Paul Chaney & FD Robertson and not escrow same. See Exhibit EE annexed hereto.

This date came the parties to this action, by counsel, upon Plaintiff's Petition pursuant to the Declaratory Judgment Act, Virginia Code Section 8.01-184, whereby Plaintiff's moved the Court to declare their ownership of coal bed methane. The parties hereto, by counsel, represented unto the Court that they had reached a compromise in this matter to the effect that under current case law, as between the Plaintiffs and the Defendant, the Plaintiffs are the owners of the coal bed methane gas pursuant to their ownership of the natural gas under the lands described in said Petition and that said Plaintiffs, as and between the parties hereto, under current case law, are entitled to any funds held in escrow by the Virginia Gas and Oil Board, and any royalties which may accrue in the future as a result of the production of said coal bed methane gas or natural gas.

It appearing that Joel Louis Absher is the owner of a 9.97 acre tract of property located on Ridge Road in the Doran section of Tazewell County by Deed dated June 15, 2006, and recorded at Deed Book 973, page 899 in the Tazewell County Circuit Court; Larry Absher and Carol Absher, husband and wife are the owners of a 7 acre tract of property, more or less, located on Ridge Road in the Doran section of Tazewell County by Deed dated September 27, 1982, and recorded at Deed Book 500, page 615 in the Tazewell Circuit Court; that Jerry and Emma Absher, husband and wife are the owners of a 15 acre tract of property located on Ridge Road in the Doran section of Tazewell County by Deed dated May 10, 1994, and recorded at Deed Book 688, page 198 in the Tazewell Circuit Court; and that the Defendant described herein is the owner of the coal only as to the property herein described.

Upon consideration of the aforesaid representations, it is hereby ADJUDGED, ORDERED AND DECREED as follows:

1. As between the Plaintiffs and the Defendant, under current case law, the Plaintiffs are the

owners of the coal bed methane gas under the land described above, and are entitled to any funds held in escrow by the Virginia Oil and Gas Board for EE-36, EE-37, EE-38, FF-37 and FF-38, as well as being entitled to any royalties generated in the future arising from the production of coal bed methane or other natural gas produced pursuant to the previously referenced pooling orders.


2. The Virginia Oil and Gas Board is directed to forthwith order payment of all principal sums and accrued interest on royalties previously deposited into the escrow account maintained by the Virginia Oil and Gas Board.

There being nothing further for consideration this matter, the Court orders the Clerk to provide a tested copy of this Order to Counsel for the Plaintiffs and for the Defendant, in this matter is stricken from the active docket.


