2. Relief Sought

(1) the disbursement of escrowed funds heretofore deposited with the Board's Escrow Agent, attributable to Tracts 999, 999A, 1H, 3A, 3B, 3C, 3E & 3F, as depicted upon the annexed table; and (2) authorization to begin paying royalties directly to Catherine Caldwell, Buckhorn Coal Company, Cathy Ward, Claude E. Dye, Doris E. Corns, Rita Hess, Deborah Hess, Jeffrey Dye, Doris Dye, Dolphas Dye, Cecil Dye, Connie J. Richardson, Danny Lee Dye, Wanda S. Richardson, Ronnie K. Dye, Michael Whited, Ferrell Whited, Herald Whited, Marty Whited & Melissa Skeens; (3) Dismissal of Coal owner: Buckhorn Coal Company.

3. Legal Authority

Va. Code Ann. § 45.1-361.1 et seq., 4 VAC 25-160-140., and relevant Virginia Gas and Oil Board Orders ("Board") heretofore promulgated pursuant to law.

Coalbed Methane

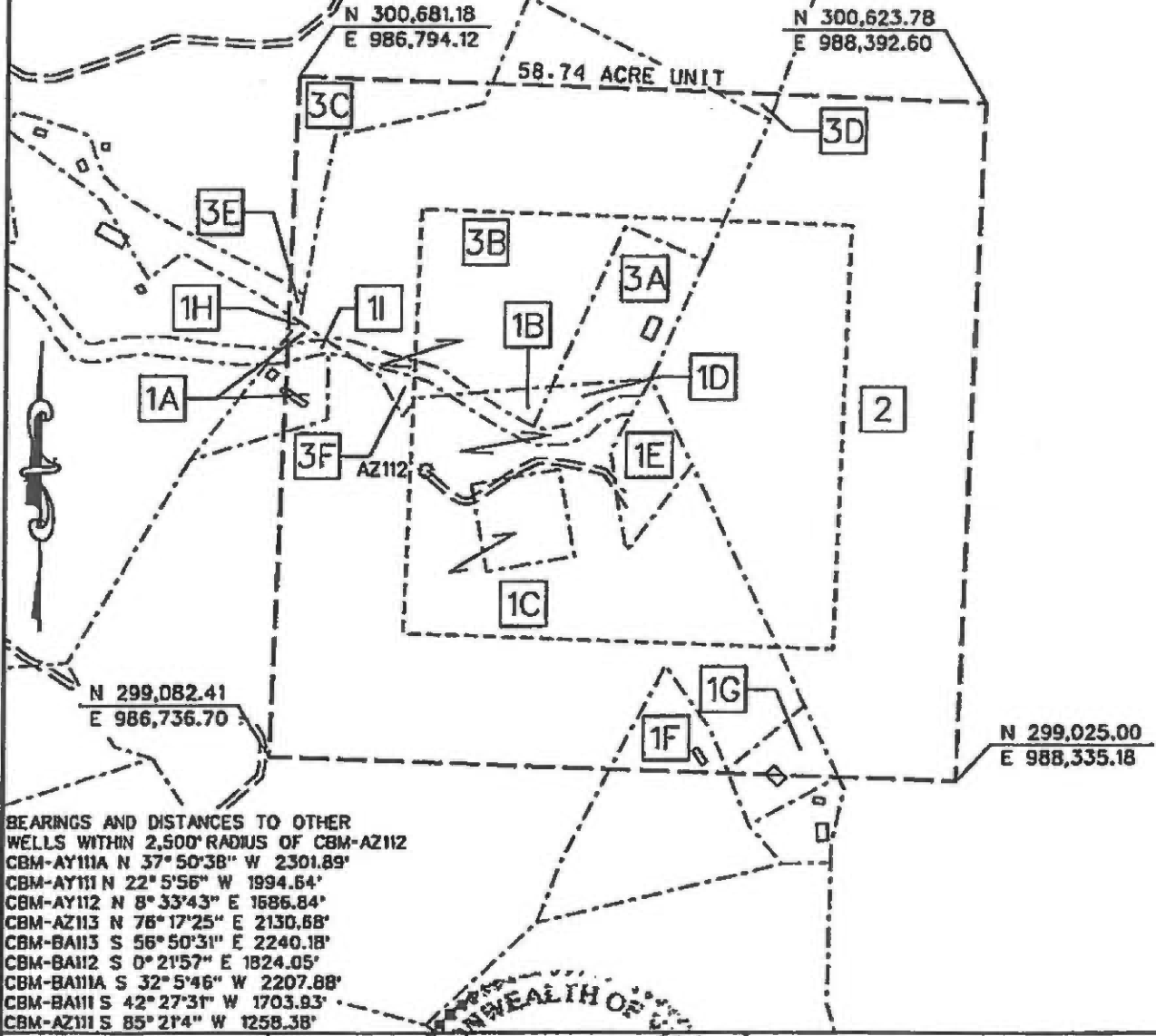
5. Factual basis for relief requested

- a. The escrow account has been overpaid; Catherine Caldwell received an additional interest per the Final Decree under Case No. CL07000605-0 executed 7/7/10. Said decree allows the Applicant and Designated Operator to pay royalties directly to the persons identified in Exhibit EE per the royalty split agreement already in place with Buckhorn Coal Company, annexed hereto and the annexed Table, further, specifies how said royalties are to be paid.
- b. Buckhorn Coal Company and Michael Whited, Ferrell Whited, Herald Whited, Marty Whited, Cathy Darlene Ward, & Melissa Skeens have entered into royalty split agreement(s). Said royalty split agreement(s) allow the Applicant and Designated Operator to pay royalties directly to the persons identified in Exhibit EE.
- c. Claude E. Dye, Doris E. Corns, Rita Hess, Deborah Hess, Jeffrey Dye, Doris Dye, Dolphas Dye, Cecil Dye, Connie J. Richardson, Danny Lee Dye, Wanda S. Richardson, & Ronnie K. Dye is the gas claimants in Tract 3A, 3B & 3F As such, is entitled to 100% of the CBM royalties now in escrow and as may be hereafter payable. See Va. Code Ann. § 45.1-361.22:2.A.
- d. That CNX Gas Company LLC has given the notice(s) required by § 45.1-361.22:2.A to all conflicting claimants identified in the above referenced pooling Order and any supplemental Orders pertaining thereto.
- e. That none of the conflicting claimants noticed have provided, within 45 days of the notice(s) given as provided in b. above, the Board, its designated agent the Director of the Division of Gas and Oil, the Operator and/or the Applicant evidence of either an agreement regarding the escrowed funds/royalties or a proceeding regarding same.
- f. That a detailed accounting in accordance with the applicable provisions of § 45.1-361.22 is submitted herewith and identified as Exhibit J.
- g. That an Exhibit identified as Table 1 is annexed hereto, and it specifies how the disbursement (s) is to be calculated and paid by the escrow agent.
- h. That Va. Code Ann. § 45.1-361.22:2.A. further provides that the Operator shall pay such royalties as may hereafter be payable directly to the gas claimant and not escrow same. See Exhibit EE annexed hereto.

6. Attestation

The foregoing Petition to the best of my knowledge, information, and belief is true and correct.

⊙ PROPOSED CBM WELL

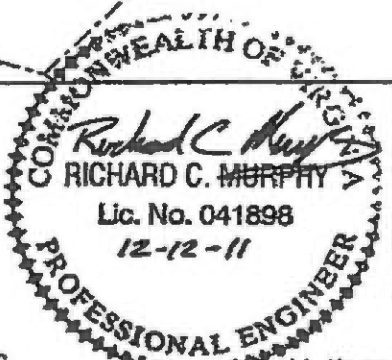
