Keen, William Tickle, Dale & Patricia Chambers; (3) Dismissal of coal owner(s): Hugh MacRae/Torch Oil & Gas Co.

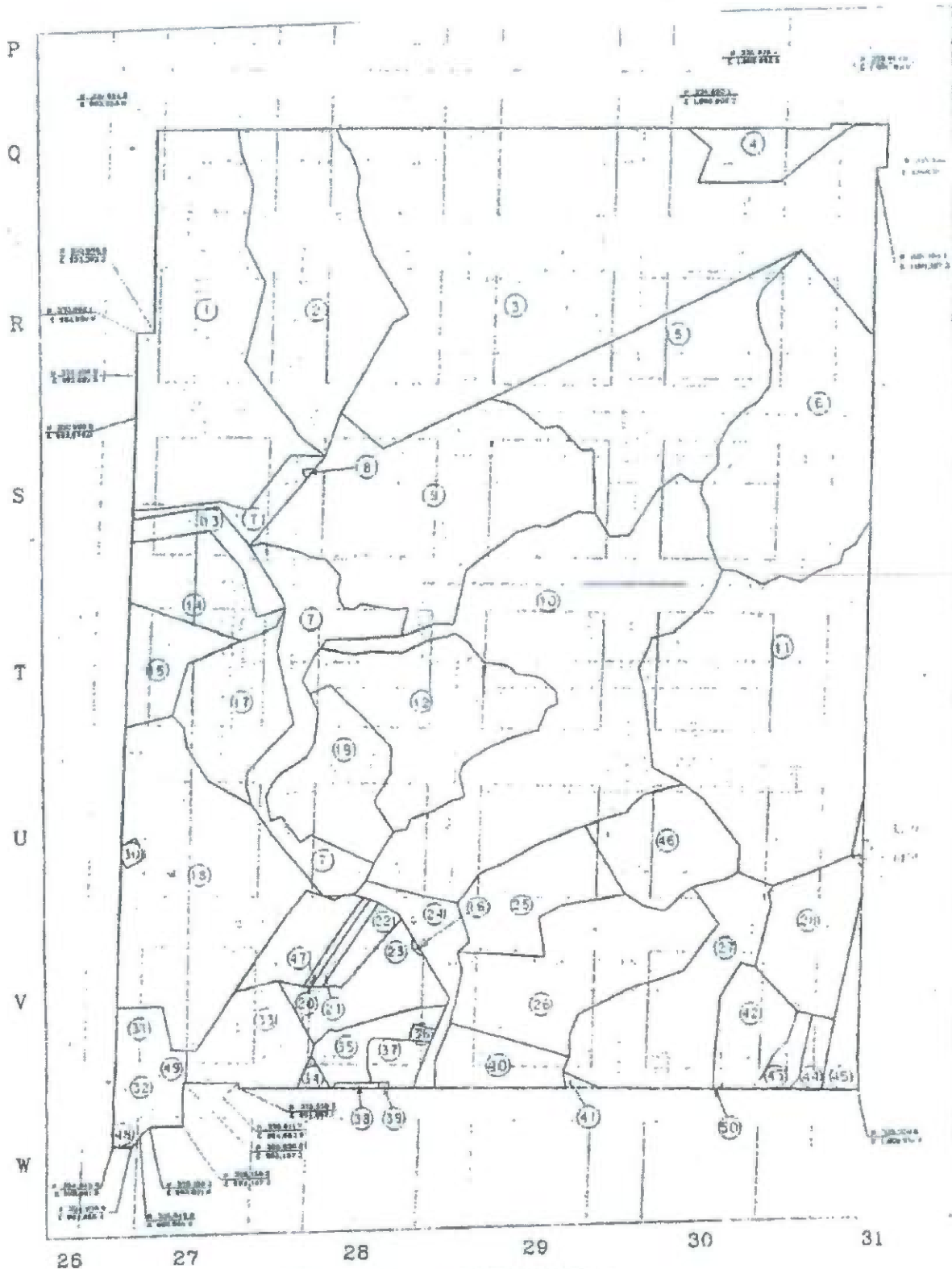

5. Factual basis for relief requested

- a. Kendris Harman, Henry F. Harman, Walter L. Keen is entitled to 100% of the CBM royalties awarded under Case No. CL 12-292, Opinion dated January 22, 2015, Said consent order allows the Applicant and Designated Operator to pay royalties directly to the person(s) identified in Exhibit EE annexed hereto and the annexed Table, further, specifies how said royalties are to be paid.
- b. Jack Kirby Mullins, Jr., Rita Jill Baker, Kathy Looney, Phyllis J. Boyd, Daniel Johnson, Russel Dean Johnson, William Tickle, Dale & Patricia Chambers, Sarah Jane Keen are the gas claimants in Tract 20, 21, 22, 23, 32, 34, 48. As such, is entitled to 100% of the CBM royalties now in escrow and as may be hereafter payable. See Va. Code Ann. § 45.1-361.22:2.A.
- c. That CNX Gas Company LLC has given the notice(s) required by § 45.1-361.22:2.A to all conflicting claimants identified in the above referenced pooling Order and any supplemental Orders pertaining thereto.
- d. That none of the conflicting claimants noticed have provided, within 45 days of the notice(s) given as provided in b. above, the Board, its designated agent the Director of the Division of Gas and Oil, the Operator and/or the Applicant evidence of either an agreement regarding the escrowed funds/royalties or a proceeding regarding same.
- e. That a detailed accounting in accordance with the applicable provisions of § 45.1-361.22 is submitted herewith and identified as Exhibit J.
- f. That an Exhibit identified as Table 1 is annexed hereto, and it specifies how the disbursement (s) is to be calculated and paid by the escrow agent.
- g. That Va. Code Ann. § 45.1-361.22:2.A. further provides that the Operator shall pay such royalties as may hereafter be payable directly to the gas claimant Jack Kirby Mullins, Jr., Rita Jill Baker, Kathy Looney, Phyllis J. Boyd, Daniel Johnson, Russel Dean Johnson, Kendris Harman, Sarah Jane Keen, Henry F. Harman, Walter L. Keen, William Tickle, Dale & Patricia Chambers and not escrow same. See Exhibit EE annexed hereto.
