Petition to disburse funds from the escrow account for well VC-536171, to all known owners in Tract 2. VGOB 07-0220-1885-01.

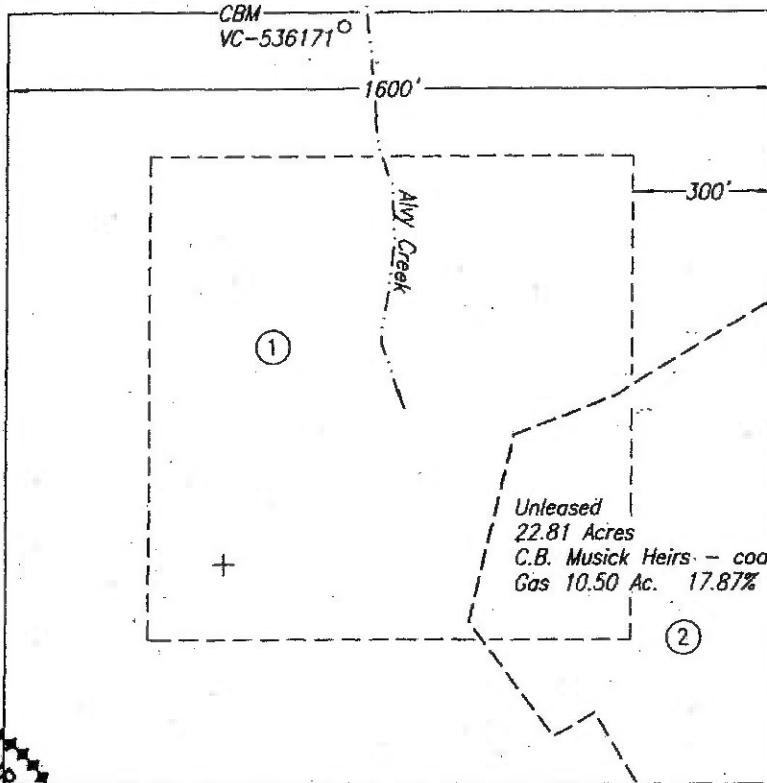

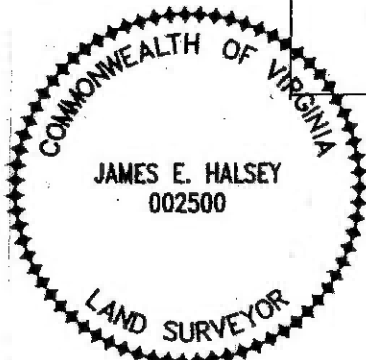
