**AMENDED AND RESTATED  
LIMITED LIABILITY COMPANY AGREEMENT  
OF  
ACIN LLC  
A Delaware Limited Liability Company**

This AMENDED AND RESTATED LIMITED LIABILITY COMPANY AGREEMENT OF ACIN LLC (the “*Company*”), dated as of October 17, 2002 (this “*Agreement*”), is adopted, executed and agreed to by NRP (Operating) LLC, a Delaware limited liability company (the “*Sole Member*”).

**RECITALS**

WHEREAS, Ark Land Company, a Delaware corporation, had executed that Limited Liability Company Agreement of ACIN LLC dated May 8, 2002 (the “*Original Agreement*”); and

WHEREAS, Ark Land Company made a capital contribution of certain assets to the Company on October 17, 2002 as described in Section 2.4 of that Contribution, Conveyance and Assumption Agreement entered into among the Company, Ark Land Company, the Sole Member, Natural Resource Partners L.P. (the “*MLP*”) and certain other parties and dated of even date herewith (the “*Contribution Agreement*”);

WHEREAS, Ark Land Company contributed all of its membership interest in the Company to the MLP in exchange for good and valuable consideration, including a limited partner interest in the MLP, as described in Section 2.8 of the Contribution Agreement; and

WHEREAS, the MLP has contributed all of its membership in the Company to the Sole Member as a capital contribution as described in Section 2.22 of the Contribution Agreement,

NOW THEREFORE, in consideration of their mutual undertakings and agreements hereunder, the parties to this Agreement undertake, agree and amend the Original Agreement as follows:


1. **Formation.** The Company has been formed as a Delaware limited liability company under and pursuant to the Delaware Limited Liability Company Act (the “*Act*”).
2. **Term.** The Company shall have a perpetual existence.
3. **Purposes.** The purposes of the Company are to carry on any lawful business, purpose or activity for which limited liability companies may be formed under the Act.
4. **Sole Member.** The Sole Member shall be the sole member of the Company.
5. **Contributions.** On May 8, 2002, in connection with the formation of the Company, Ark Land Company made an initial contribution of capital to the Company in the amount of \$1000.00 in exchange for a 100% membership interest

in the Company. On October 17, 2002, by operation of the Contribution Agreement, the 100% membership interest was ultimately contributed to the Sole Member. Without creating any rights in favor of any third party, the Sole Member may, from time to time, make additional contributions of cash or property to the capital of the Company, but shall have no obligation to do so.

6. **Distributions.** The Sole Member shall be entitled (a) to receive all distributions (including, without limitation, liquidating distributions) made by the Company, and (b) to enjoy all other rights, benefits and interests in the Company.
7. **Management.** The management of the Company shall be exclusively vested in the Sole Member, the sole member of the Company.
8. **Dissolution.** The Company shall dissolve and its affairs shall be wound up at such time, if any, as the Sole Member may elect. No other event will cause the Company to dissolve.
9. **Governing Law.** THIS AGREEMENT IS GOVERNED BY AND SHALL BE CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF DELAWARE (EXCLUDING ITS CONFLICT-OF-LAWS RULES).

**IN WITNESS WHEREOF**, the undersigned, the sole member of the Company, has caused this Amended and Restated Limited Liability Company Agreement of ACIN LLC to be duly executed as of the 17th day of October 2002.

This e-mail is to confirm that EQT will be submitting a payment of \$6,506.56 to First Bank for Docket 1372 (VC-535601). EQT agrees that there was an incorrect payment made in the prior disbursement. EQT will not be adding interest to this payment due to the following:

1. The *incorrect* disbursement payment was based on the total amount in escrow at the time of disbursement (\$36,040.76). This amount would have included interest that had accrued while the account was in escrow.
2. The correction that we are making is based on that same amount. Thus, our correction payment is accounting for any interest that had accrued prior to the disbursement.

Thanks for checking on this. **But i think EQT is wrong on this.** The Supplemental order has only an exhibit B. Assuming there were no splits among those listed in conflict which were not noted in the order, then there would have been 36.98 acres in escrow and 21.79 acres paid out no conflict. Of the 36.98 acres in escrow the

portion of the tract which Hamilton and ACIN signed a split with was 13.3533 acres of tract 1. 13.3533/36.98 acres is 36.10% of escrow. When you look at the disbursement on 10/2009 - \$19,519.68 was removed from the total of \$36,285.68 (beginning plus deposit minus fees). That represents 53.8% of escrow. There are two exhibits in this order page 4 table 1 is incorrect (disbursing the entire tract (20.03 acres) between Hamilton (15.02 acres) and ACIN (5.01 acres)) and Page 14 is correct showing the total as of 3/2009 as \$11,946.60 representing the split between ACIN and Hamilton. The disbursement was made by the wrong table. the reason being that they disburse by percentage and not by numbers - so the only one that could be followed was the percent shown in the wrong table. If my assessment is correct then EQT/Range needs to pay \$6,506.56 plus interest back into escrow. They may now be paying into escrow in accordance with the actual tracts in escrow and paying directly the proper decimal interest - but the problem is that they disbursed all royalties due to tract 1.

ALSO THE SPLIT BETWEEN HAMILTON AND ACIN STATES 75/25 - THAT IS NOT A 1/3RD AND 2/3RD SPLIT - the calculated NRI is correct.

Attached is a worksheet (rough revision of Exhibit E) which includes the Lantz interest on Tract 1. The NRI's highlighted in yellow add up to the current NRI being paid/escrowed to First Bank, AB# 113816 which is .05025. I also verified that the split between ACIN and the Hamilton's was split correctly (1/3 and 2/3): TOTAL NRI .0284, split with ACIN receiving .00710 and the Hamilton's receiving .02130).

Sally,

I had a call from a gas owner with interest in VC535601 (1372), so i went through the orders to confirm the escrowed acres with that on the estimator. I believe I may have found a problem with disbursement order 1372-01. I did some additional digging and it looks like a disbursement was made from this unit (8/31/2006 for \$364.68). So was the disbursement approved on 7/21/2009 the second one?

At any rate, the real reason why i am writing you is with respect to the 7/21/2009 approved disbursement.

Both the pooling order and supplemental order for this unit shows Tract 1 as 20.03 acres assigned as follows: James J. Hamilton -oil and gas 2/3rd interest and Susan C. & Kurt Lantz oil and gas 1/3 interest.

However, in the disbursement application, EQT requested the disbursement of 100% of the interest in tract 1 according to Table 1. The table shows 75% of 100% of the interest as going to James J. Hamilton and 25% of the 100% interest going to ACIN/NRP. Tract 1 is no longer listed in Exhibit E. There is no Exhibit EE. At any rate, I checked and \$19,515.68 came out of escrow on 10/2009 - which is consistent with the % of the 20.03 acres was to the whole of the acres escrowed.

According to the information submitted with the application, On April 6., 2009, NRP sent a letter to EQT enclosing a split agreement - that letter clearly states "James J. Hamilton's 2/3 interest". Also attached was the split letter - the RE: shows "Permanent Split of CBM Roylty James J. Hamilton - oil and gas 2/3 and Susan C. and Kurtz Lantz oil and gas 1/3rd interest 54.55 acres VC535601. The letter also states "that it is also agreed that the royalty from any **future** cbm wells drilled upon the subject tract or upon other lands which the subject tract or upon other lands in which the subject tract is pooled therewith will be permanently split in the same 75/25% proportion." James Hamilton signed it on 4/4/2009 - but his signature is not notarized in the copy sent. I did not see where Lantz signed it and I suspect she never did. But even if she did the disbursement order did not show the percent assigned to her and she does not appear to have been notified.

I noticed that there is also interest assigned to Lantz in tract 4, NRP/ACIN is also shown as the coal owner - this tract is still in escrow .

At any rate without knowing what interest EQT actually paid into escrow it is impossible to figure out the amount estimated for individuals with interest in this unit.

Would you please check on this
