**AMENDED AND RESTATED
LIMITED LIABILITY COMPANY AGREEMENT
OF
ACIN LLC
A Delaware Limited Liability Company**

This AMENDED AND RESTATED LIMITED LIABILITY COMPANY AGREEMENT OF ACIN LLC (the “*Company*”), dated as of October 17, 2002 (this “*Agreement*”), is adopted, executed and agreed to by NRP (Operating) LLC, a Delaware limited liability company (the “*Sole Member*”).

RECITALS

WHEREAS, Ark Land Company, a Delaware corporation, had executed that Limited Liability Company Agreement of ACIN LLC dated May 8, 2002 (the “*Original Agreement*”); and

WHEREAS, Ark Land Company made a capital contribution of certain assets to the Company on October 17, 2002 as described in Section 2.4 of that Contribution, Conveyance and Assumption Agreement entered into among the Company, Ark Land Company, the Sole Member, Natural Resource Partners L.P. (the “*MLP*”) and certain other parties and dated of even date herewith (the “*Contribution Agreement*”);

WHEREAS, Ark Land Company contributed all of its membership interest in the Company to the MLP in exchange for good and valuable consideration, including a limited partner interest in the MLP, as described in Section 2.8 of the Contribution Agreement; and

WHEREAS, the MLP has contributed all of its membership in the Company to the Sole Member as a capital contribution as described in Section 2.22 of the Contribution Agreement,

NOW THEREFORE, in consideration of their mutual undertakings and agreements hereunder, the parties to this Agreement undertake, agree and amend the Original Agreement as follows:


1. **Formation.** The Company has been formed as a Delaware limited liability company under and pursuant to the Delaware Limited Liability Company Act (the “*Act*”).
2. **Term.** The Company shall have a perpetual existence.
3. **Purposes.** The purposes of the Company are to carry on any lawful business, purpose or activity for which limited liability companies may be formed under the Act.
4. **Sole Member.** The Sole Member shall be the sole member of the Company.
5. **Contributions.** On May 8, 2002, in connection with the formation of the Company, Ark Land Company made an initial contribution of capital to the Company in the amount of \$1000.00 in exchange for a 100% membership interest

in the Company. On October 17, 2002, by operation of the Contribution Agreement, the 100% membership interest was ultimately contributed to the Sole Member. Without creating any rights in favor of any third party, the Sole Member may, from time to time, make additional contributions of cash or property to the capital of the Company, but shall have no obligation to do so.

6. **Distributions.** The Sole Member shall be entitled (a) to receive all distributions (including, without limitation, liquidating distributions) made by the Company, and (b) to enjoy all other rights, benefits and interests in the Company.
7. **Management.** The management of the Company shall be exclusively vested in the Sole Member, the sole member of the Company.
8. **Dissolution.** The Company shall dissolve and its affairs shall be wound up at such time, if any, as the Sole Member may elect. No other event will cause the Company to dissolve.
9. **Governing Law.** THIS AGREEMENT IS GOVERNED BY AND SHALL BE CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF DELAWARE (EXCLUDING ITS CONFLICT-OF-LAWS RULES).

IN WITNESS WHEREOF, the undersigned, the sole member of the Company, has caused this Amended and Restated Limited Liability Company Agreement of ACIN LLC to be duly executed as of the 17th day of October 2002.

Re: House Bill 2058 - Petition for Disbursement from Escrow

Dear Mr. Wooten,

House Bill 2058 was signed by the Governor and became law effective July 1, 2015. This new law established a process for the Virginia Gas and Oil Board to disburse monies placed in escrow because of conflicting claims (between coal owners and the oil and gas owners).

In general, under this new law escrowed funds are to be paid to oil and gas owners unless the coal owner(s) provides the operator, EQT and The Division of Gas and Oil "with evidence of a proceeding" [as in a court case] "or an agreement." The new law gives coal owners/coal claimants **45 days** from the date of notice to provide this evidence.

Please be advised that pursuant to House Bill 2058, EQT will be applying to the Board for release of funds in escrow to the oil and gas owners for the following coalbed methane gas wells:

If there is a prior proceeding or agreement that would prohibit the release of funds to the oil and gas owner, you **must** provide evidence of such to EQT and The Division of Gas and Oil within **45 days** of receipt of this letter.
