(1) the disbursement of escrowed funds heretofore deposited with the Board's Escrow Agent, attributable to Tract 4, as depicted upon the annexed table; and (2) authorization to begin paying royalties directly to: H.C. Bostic Coal Co., Inc.

Va. Code Ann. § 45.1-361.1 et seq., 4 VAC 25-160-140., and relevant Virginia Gas and Oil Board Orders ("Board") heretofore promulgated pursuant to law.

4. Type of Well(s)

CBM - No dismissal

5. Factual basis for relief requested

- a. H.C. Bostic Coal Co., Inc. is entitled to 100% of the CBM royalties awarded under Case No. 16 -324, Opinion dated May 4, 2016, Said decision allows the Applicant and Designated Operator to pay royalties directly to the person(s) identified in Exhibit EE annexed hereto and the annexed Table, further, specifies how said royalties are to be paid.
- b. That a detailed accounting in accordance with the applicable provisions of § 45.1-361.22 is submitted herewith and identified as Exhibit J.
- c. That an Exhibit identified as Table 1 is annexed hereto, and it specifies how the disbursement (s) is to be calculated and paid by the escrow agent.
- d. That Va. Code Ann. § 45.1-361.1 et seq., 4 VAC 25-160-140. further provides that the Operator shall pay such royalties as may hereafter be payable directly to the gas claimant H.C. Bostic Coal Co., Inc. and not escrow same. See Exhibit EE annexed hereto.

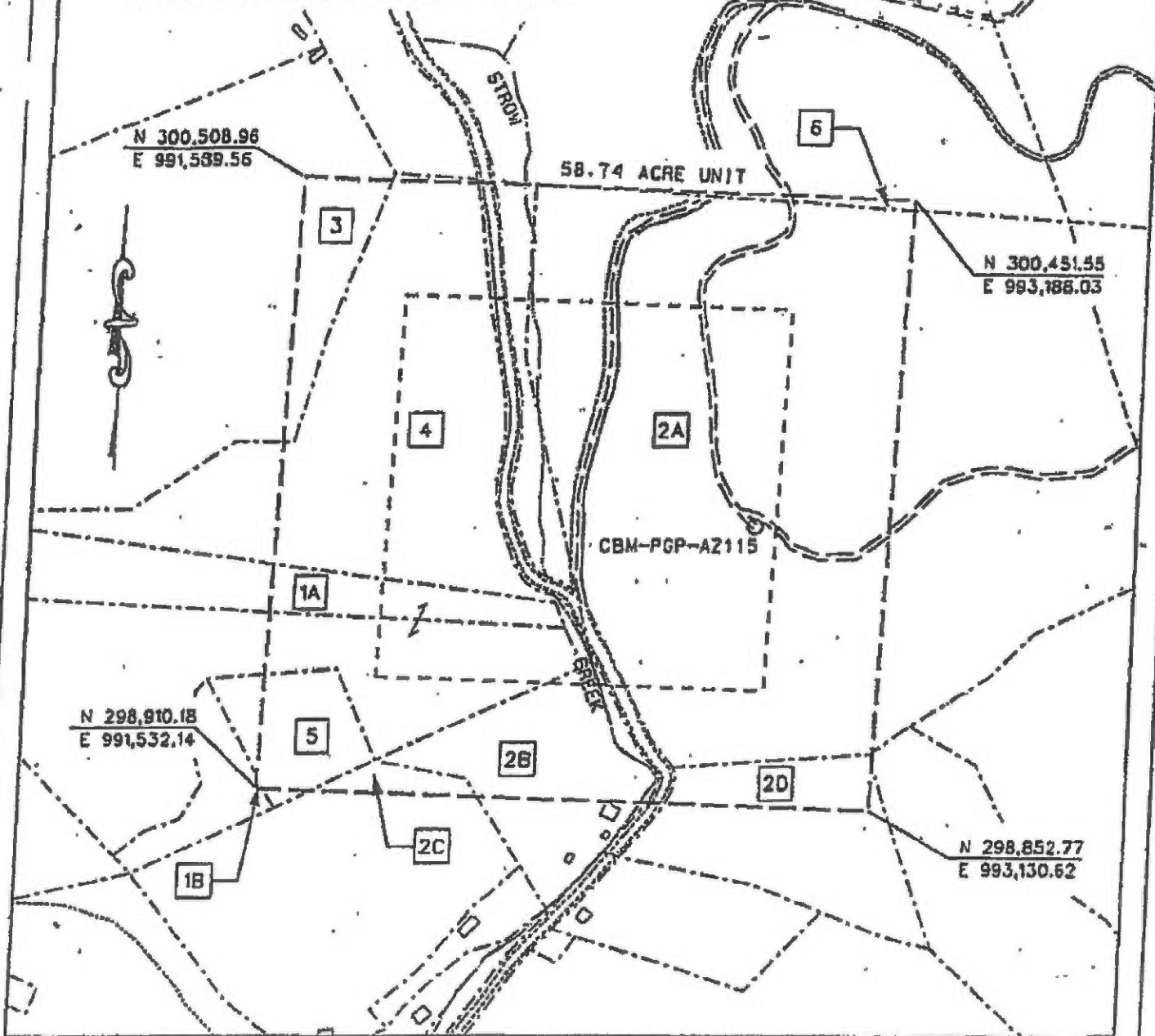


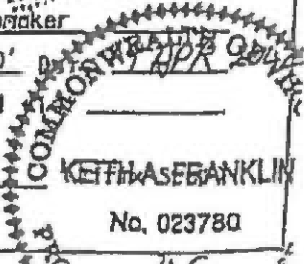



Upon consideration thereof, it is ADJUDGED, ORDERED, and DECREED that Plaintiff, H.C. Bostic Coal Company, Inc., being the owner of the subject property in fee, with the exception of the surface having been previously conveyed as setout above, is the owner of the gas estate relative to said tract, including, but not limited to, those portions of said parcel identified as Tract 4 of Unit AY-115 (VGOB Docket No. 01-0821-0917), Tract 4 of Unit AZ-114 (VGOB Docket No. 03-0819-1167), and Tract 4 of Unit AZ-115 (VGOB Docket No. 02-0521-1028).

There appearing nothing further to be done in this matter, the Guardian ad Litem shall be awarded a fee of \$300.00, and the Clerk is directed to strike this matter from the active docket of the Court, forwarding a certified copy of this order to counsel of record.
