Brown, Jackie Brown, Danny Brown, Sheila Osborne, Melissa Spencer, Tammy Tucker, Christine Hubbard, Barbara Barnhart, Connie Middleton, Pauline Christian, Joseph C. Brown, Pamela Diane Osborne, Teresa Hubbard, Susan Barton, Heather Shelton, Rex Osborne, Anthony Fuller, and Jeffrey Donald Fuller

3. Legal Authority

Va. Code Ann. § 45.1-361.1 et seq., 4 VAC 25-160-140., and relevant Virginia Gas and Oil Board Orders ("Board") heretofore promulgated pursuant to law.

Coalbed Methane

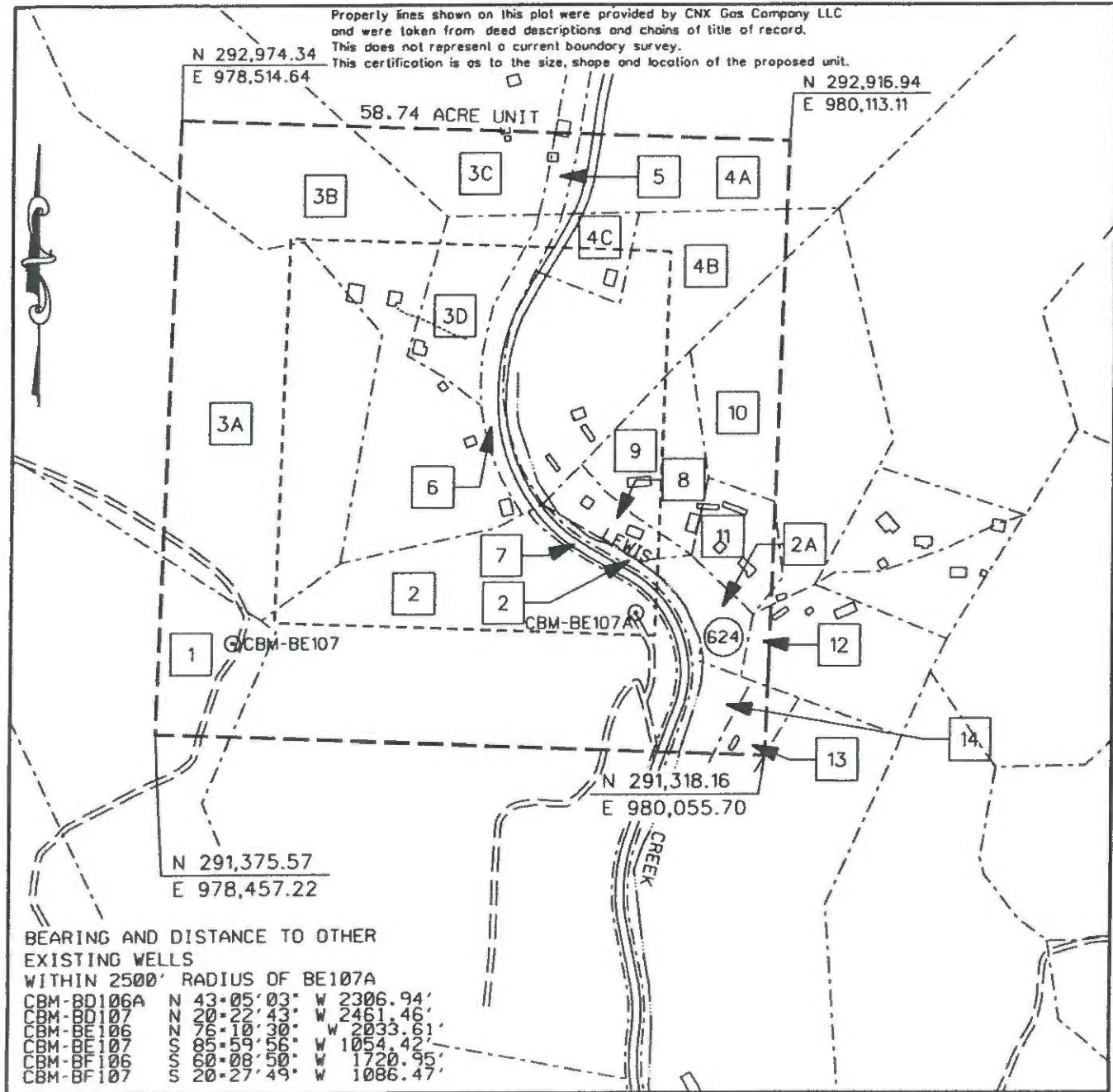
5. Factual basis for relief requested

- a. Garden Realty Corporation, CNX Gas Company LLC, Larry C. Brown, Christopher Clark, John Clark, Jr., Dakota Clark, Raymond Alley, John R. Brown, Jackie Brown, Danny Brown, Sheila Osborne, Melissa Spencer, Tammy Tucker, Christine Hubbard, Barbara Barnhart, Connie Middleton, Pauline Christian, Joseph C. Brown, Pamela Diane Osborne, Teresa Hubbard, Susan Barton, Heather Shelton, Rex Osborne, Anthony Fuller, and Jeffrey Donald Fuller are the gas claimants in a portion of Tr. 10. As such Garden Realty Corporation, CNX Gas Company LLC, Larry C. Brown, Christopher Clark, John Clark, Jr., Dakota Clark, Raymond Alley, John R. Brown, Jackie Brown, Danny Brown, Sheila Osborne, Melissa Spencer, Tammy Tucker, Christine Hubbard, Barbara Barnhart, Connie Middleton, Pauline Christian, Joseph C. Brown, Pamela Diane Osborne, Teresa Hubbard, Susan Barton, Heather Shelton, Rex Osborne, Anthony Fuller, and Jeffrey Donald Fuller are entitled to 100% of the CBM royalties attributable to their gas claims that are now in escrow and as may be hereafter payable. See Va. Code Ann. § 45.1-361.22:2.A.
- b. Tract 12 is fee property, of which a portion was previously placed into escrow due to unknown and unlocatable parties. Ongoing due diligence efforts have revealed numerous changes to the A.J. Brown Heirs interests. CNX is requesting that funds placed in escrow attributable to a portion of Tract 12 be disbursed to CNX to allow for internal corrections to all parties and resolution of the entire tract.
- c. That CNX Gas Company LLC has previously given the notice(s) required by § 45.1-361.22:2.A to all conflicting coal claimants identified in the above referenced pooling Order and any supplemental Orders pertaining thereto.
- d. That when the Board granted Petitioner's Miscellaneous Petition in VGOB 05-1015-1506-02, it dismissed the coal claimant(s) M.O. Burke Heirs as a Respondent to these proceedings. Accordingly, M.O. Burke Heirs were not provided further notice under § 45.1-361.19 and 22 of the hearing set on this Petition.
- e. That a detailed accounting in accordance with the applicable provisions of § 45.1-361.22 is submitted herewith and identified as Exhibit J.
- f. That an Exhibit identified as Table 1 is annexed hereto, and it specifies how the disbursement (s) is to be calculated and paid by the escrow agent.
- g. That Va. Code Ann. § 45.1-361.22:2.A. further provides that the Operator shall pay such royalties as may hereafter be payable directly to the gas claimant Garden Realty Corporation, CNX Gas Company LLC, Larry C. Brown, Christopher Clark, John Clark, Jr., Dakota Clark, Raymond Alley, John R. Brown, Jackie Brown, Danny Brown, Sheila Osborne, Melissa Spencer, Tammy Tucker, Christine Hubbard, Barbara Barnhart, Connie Middleton, Pauline Christian, Joseph C. Brown, Pamela Diane Osborne, Teresa Hubbard, Susan Barton, Heather Shelton, Rex Osborne, Anthony Fuller, and Jeffrey Donald Fuller and shall not escrow same. See Exhibit EE annexed hereto.

6. Attestation

The foregoing Petition to the best of my knowledge, information, and belief is true and correct.

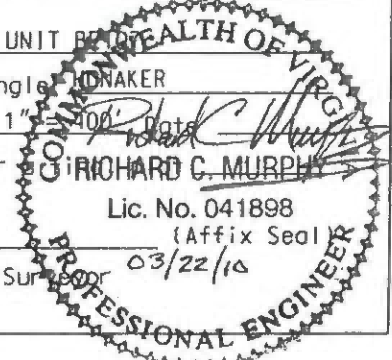
