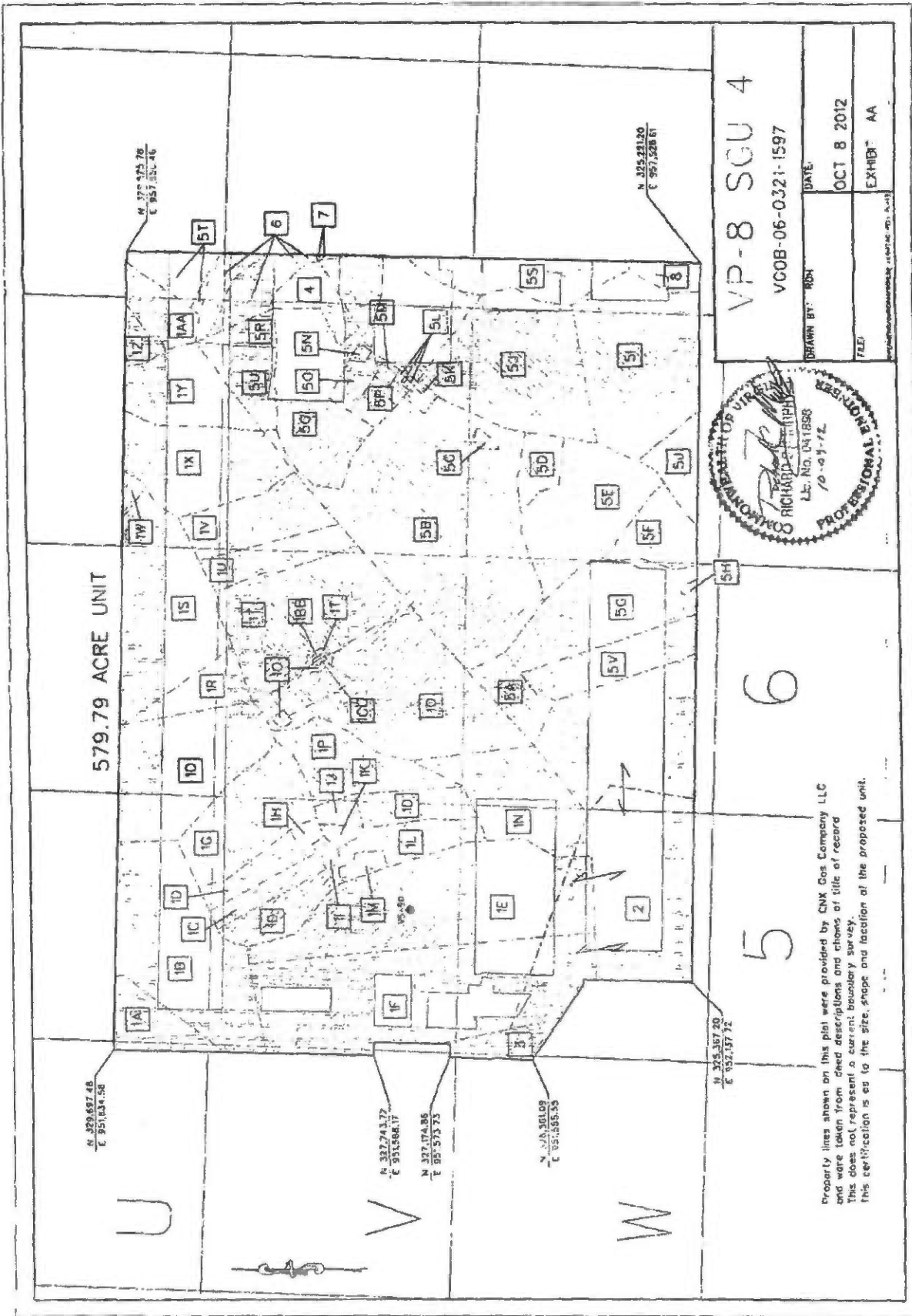

Accordingly, H-W Financial, LLC (formerly Harrison-Wyatt, LLC) was not provided further notice under § 45.1-361.19 and 22 of the hearing set on this Petition.
- d. That a detailed accounting in accordance with the applicable provisions of § 45.1-361.22 is submitted herewith and identified as Exhibit J.
- e. That an Exhibit identified as Table 1 is annexed hereto, and it specifies how the disbursement (s) is to be calculated and paid by the escrow agent.

COAL-BED METHANE SPLIT AGREEMENT

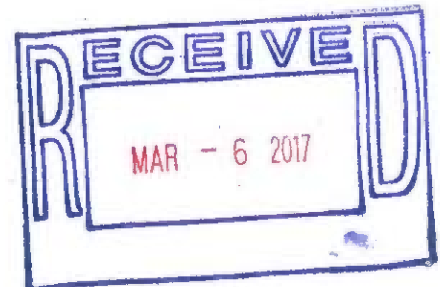
THIS AGREEMENT, between MADELINE MULLINS HUNT, the party of the first part, and BOBBY CRAIG JACKSON and TRACY JACKSON, husband and wife, parties of the second part.

WHEREAS, the parties of the second part own the surface and residuary estate to a boundaries of real estate in Buchanan County referenced in Deed Book 424 Page 742 and Deed Book 565 Page 130 recorded in the Buchanan County Circuit Court Clerks office; and

WHEREAS, the party of the first part own the coal and mineral estate located beneath certain portions of the real estate owned by the parties of the second part referenced in the preceding paragraph; and

WHEREAS, the parties hereto recognize that, in those areas where coal bed methane gas has been, and will be, developed and produced, and in which the party of the first part owns the coal and mineral estate and the party of the second part owns the surface and residual estate, the parties may be conflicting claimants to the coal bed methane; and

WHEREAS, monies are currently held in escrow by the Virginia Gas and Oil Board relative to coal bed methane being produced in units including, but not limited to, Unit W-8, Unit X-8, Unit VP8SGU4, and Unit VP8SGU5, in which the parties of the first and second part own between them the surface/residual and mineral estates, and will continued to be placed in escrow until ownership is established by a court of competent jurisdiction, or the matter is compromised and settled by the parties; and



WHEREAS, in order to release those funds currently being held in escrow, and to avoid the future escrow of royalties from those area referenced above, the parties hereto have reached an agreement as to the release of funds currently held in escrow, and payment of future royalties, and desire by this instrument to set forth that agreement.

NOW THEREFORE, in consideration of the premises which are incorporated herein as part of this agreement and not as mere recitals, and other good and valuable consideration, the sufficiency and receipt of which are hereby acknowledge, the parties intending to be legally bound, hereby agree as follows:

1. THE PARTIES AGREE TO SPLIT ANY FUNDS CURRENTLY BEING HELD IN ESCROW RELATING TO THE PRODUCTION OF COAL-BED METHANE FROM THE UNITS W-8 (Tract 2), X-8 (Tract 4), VP8SGU4 (Tract 8), and VP8SGU5 (Tract 5) ON A 50/50 BASIS, AND TO ACCEPT 50% OF ANY FUTURE ROYALTIES THAT WOULD OTHERWISE BE DUE THEM RELATIVE TO THE SAME.

2. The terms of this agreement shall supersede the terms on any forced pooling order entered prior to, contemporaneous with, or subsequent to the date of this agreement.

3. This agreement shall remain in full force and effect until the exhaustion of all coalbed methane/coalseam gas underlying only those tracts of properties where the party of the first part owns the coal and mineral estate, and the parties of the second part owns the surface and residuary estate, as previously referenced.

4. This agreement states the entire contract between the parties and no representation or promise, oral or written, on behalf of any party shall be binding unless contained herein.

5. This agreement shall be binding upon the successor and assigns of the parties.



Dear Property Owner,

House Bill 2058 was signed by the Governor and became law effective July 1, 2015. This new law requires the Virginia Gas and Oil Board to disburse monies placed in escrow because of conflicting claims (between coal owners and oil and gas owners) to coalbed methane gas royalties to the oil and gas owners of the tracts in this Unit.

In general, under this new law escrowed funds are to be paid to oil and gas owners unless the coal owner(s) provides the operator CNX and the Division of Gas and Oil "with evidence of a proceeding" [as in a court case] "or an agreement." The new law gives coal owners/coal claimants 45 days from the date you get this letter to provide that evidence.

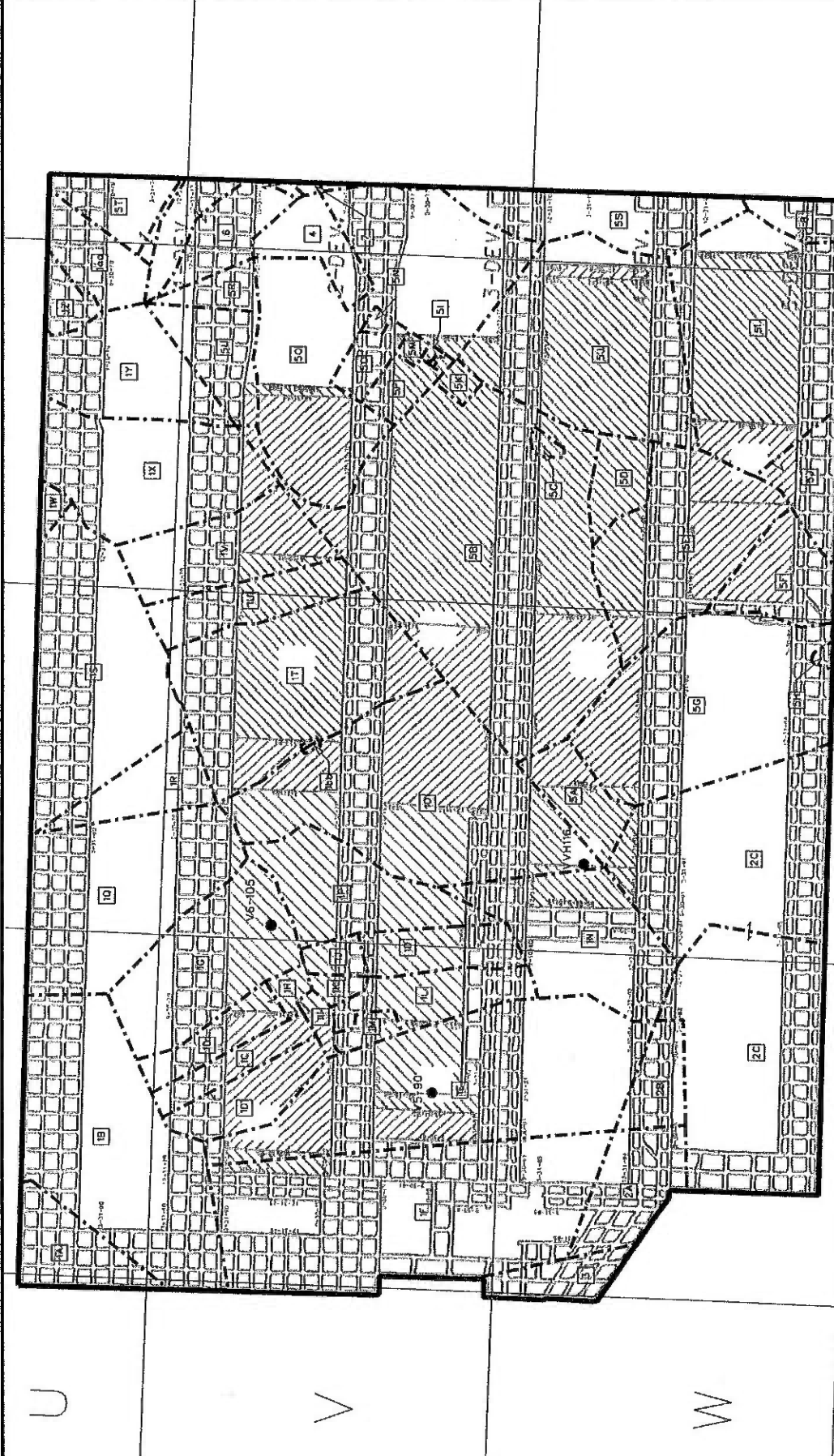
