- (3) Dismissing the Respondent surface owners named above.

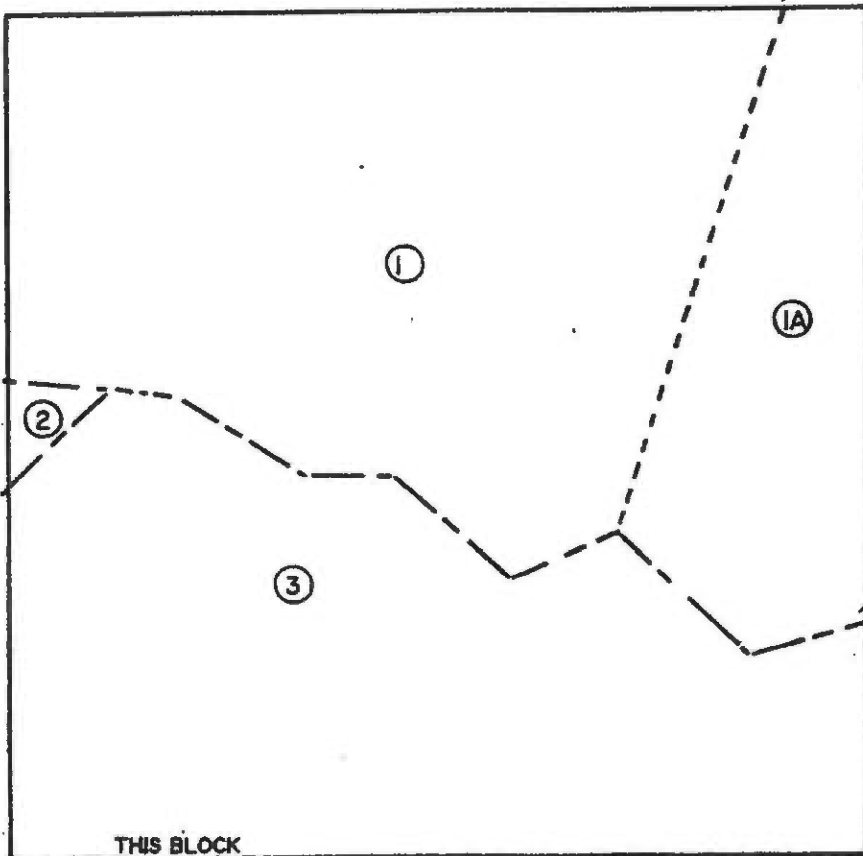
