PETITION FOR ORDER OF DISBURSEMENT OF ESCROW FUNDS

1. Petitioner and its counsel

2. Relief Sought

(1) the disbursement of escrowed funds heretofore deposited with the Board's Escrow Agent, attributable to Tracts 2 & 4, as depicted upon the annexed table; (2) authorization to begin paying royalties directly to John Keene; CNX Gas Company LLC, Bernie Darin Dye, and HC Bostic Coal Company; and (3) Dismissal of Coal Owner(s) Buckhorn Coal Co, Larry G. Dye, Deborah Murphy, Addavene Alicie, Betty Smith, Sharon Cole, Ted Rasnake, Teresa Chafin, Lois Musick, Vivian Hall, Earl Maness, Shirley Mitchell, Dorothy Smith, Juanita Dembeck, Della Dembeck, Brenda Fincham, Henry Hicks, Delilah Sesser, Kenneth Lester, Wanda Russell, Larry Compton, Betty Snead, Robert Compton, Goldie Whitt, Mary Byrd, Margaret Peck, Joy O'Brien, Sue Toler, Theresa Reel, Donna Dishner, Kenneth Wilson, Michael Wilson, Bryan Wilson, John Scott, Michelle Cooper, Andrew Justice, Patricia Chisholm, David Noel, Joe Noel, and Bernie Dye.

3. Legal Authority

Va. Code Ann. § 45.1-361.1 et seq., 4 VAC 25-160-140., and relevant Virginia Gas and Oil Board Orders ("Board") heretofore promulgated pursuant to law.

4. Type of Well(s)

Coalbed Methane

5. Factual basis for relief requested

- a. CNX Gas Company LLC is entitled to 100% of the CBM royalties awarded under Case No. 16-1165, Opinion dated July 3, 2019. Said decision allows the Applicant and Designated Operator to pay royalties directly to the person(s) identified in Exhibit EE annexed hereto, as well as making a payment to each attorney on behalf of their client(s); John Keene (Item 9 - \$100,000.00 (\$15,000.00 balance after a portion (\$85,000) paid from docket 0874-02 escrow account), with the remaining balance in escrow to be paid to CNX Gas Company LLC pursuant to Item 10 of referenced order; and the annexed Table, further, specifies how said royalties are to be paid.
- b. Bernie Darin Dye and HC Bostic Coal Company are the gas claimant(s) in Tracts 4. As such Bernie Darin Dye and HC Bostic Coal Company are entitled to 100% of the CBM royalties now in escrow and as may be hereafter payable. See Va. Code Ann. § 45.1-361.22:2.A.
- c. That Pocahontas Gas LLC (formerly CNX Gas Company LLC) has given the notice(s) required by § 45.1-361.22:2.A to all conflicting claimants identified in the above referenced pooling Order and any supplemental Orders pertaining thereto.
- d. That none of the conflicting claimants noticed have provided, within 45 days of the notice(s) given as provided in b. above, the Board, its designated agent the Director of the Division of Gas and Oil, the Operator and/or the Applicant evidence of either an agreement regarding the escrowed funds/royalties or a proceeding regarding same.
- e. That a detailed accounting in accordance with the applicable provisions of § 45.1-361.22 is submitted herewith and identified as Exhibit J.
- f. That an Exhibit identified as Table 1 is annexed hereto, and it specifies how the disbursement (s) is to be calculated and paid by the escrow agent.
- g. That Va. Code Ann. § 45.1-361.22:2.A. further provides that the Operator shall pay such royalties as may hereafter be payable directly to the gas claimant Bernie Darin Dye and HC Bostic Coal Company and not escrow same. See Exhibit EE annexed hereto.

6. Attestation

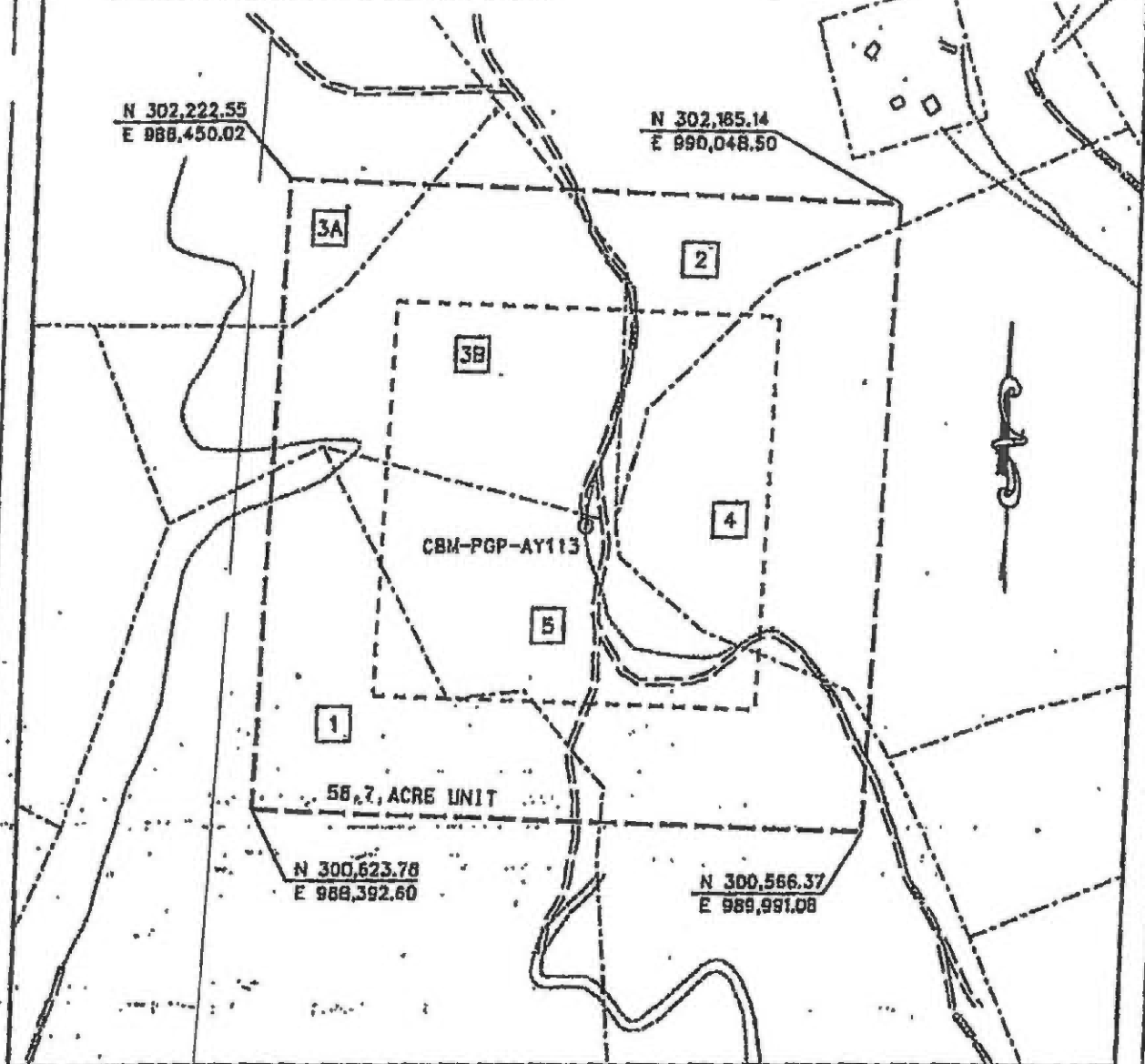

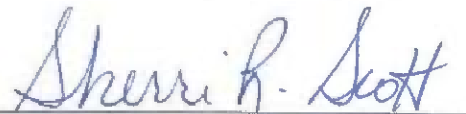

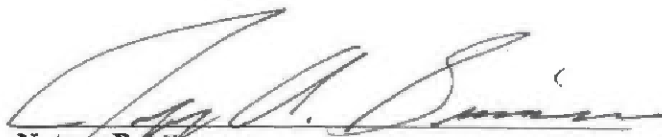

House Bill 2058 was signed by the Governor and became law effective July 1, 2015. This new law requires the Virginia Gas and Oil Board to disburse monies placed in escrow because of conflicting claims (between coal owners and oil and gas owners) to coalbed methane gas royalties to the oil and gas owners of the tracts in this Unit.

In general, under this new law escrowed funds are to be paid to oil and gas owners unless the coal owner(s) provides the operator CNX and the Division of Gas and Oil "with evidence of a proceeding" [as in a court case] "or an agreement." The new law gives coal owners/coal claimants 45 days from the date you get this letter to provide that evidence.

Enclosed herewith please find a copy of the 45 day Notice of Filing. Please read the Notice carefully to be sure you understand that you have 45 days to provide evidence to the operator CNX Gas Company LLC at the address above **and** the Division of Gas and Oil at PO Draw 159, Lebanon, VA 24266

THIS DAY came the Plaintiffs and Swain Perkins, by T. Shea Cook Counsel; the now known but previously unknown heirs of Alta Perkins, being Larry Douglas Perkins, Linda Perkins Hale, Aaron Perkins and Daniel Perkins, successors of Ashby Perkins, a deceased son of Alta Perkins, and Judy Perkins Hess, Michael Perkins, Manuel Perkins, Barbara Perkins Roman, Darrell Perkins, Frances Perkins Forbes, Katie Perkins Miller, Jeanie Perkins Howell, Rickie Allen Perkins, and Derek Perkins the successors of Paul Perkins, a deceased son of Alta Perkins, by John Keene Counsel; Edward Sears, Judith Sears, Laurie Stras Thomas, Cynthia Annette Kohout, Joseph Stras, V, and Marion Stras by Claiborne Eldrup- Jorgensen, by Catherine O'Brien Counsel; and CNX Gas Company LLC, by David Grant Altizer and Jonathan T. Blank Counsel, and announced to the Court that these parties, being the only parties remaining in interest, had reached a settlement of the matter among them.

Upon review of the pleadings, reports filed, and representations of the parties, it appears to the Court as follows;

1. All necessary parties are before the Court. Previously, the Court ruled the unknown heirs of S. J. and Susan Corn, the unknown heirs of Scott Israel, and the unknown heirs of David Keene had no interest in the oil and gas estate under the property that is subject to this litigation. Further, neither Renia Perkins nor Dorothy Perkins nor the heirs of Joseph Stras, B. W. Stras or Augustus White, other than those represented by Catherine D. O'Brien, responded, and they are in default.

2. But for the heirs and successors of Alta Perkins, neither the plaintiffs nor the heirs of B. W. Stras, Joseph Stras, and Augustus White have a proved interest in the gas and oil estate under the property that is subject to this litigation.

3. The plaintiffs have not proved a claim other than as heirs of Alta Perkins, and together with Swain Perkins, CNX Gas Company LLC, and the formally unknown heirs of Alta Perkins now represented by John Keene, they are the owners of the gas and oil estates on and under the property that is the subject of this litigation by reason of being successors in interest to Alta Perkins.

4. The plaintiffs, Swain Perkins, the heirs of B. W. Stras, Joseph Stras and Augustus White who answered and are represented by Catherine D. O'Brien, and those heirs of Alta Perkins represented by John Keene have agreed, in compromise of their claimed interests, to transfer those claimed interests to CNX Gas Company LLC, which also has interests under Alta Perkins, in exchange for a share of the current moneys in escrow held by the Virginia Gas and Oil Board as to the 55.5 acre tract, the property subject to this litigation, in Units AW112, AW113, AX112, AX113, AX114, AY 113, and AY114, after

deducting therefrom the costs authorized by the Court as set forth below. As of April 30, 2019, the total amount in escrow for these units as they related to the 55.5 acre tract was \$576,944.82.

5. Upon transfer of the above mentioned claimed interests, CNX Gas Company LLC will own 100% of the gas and oil under the said 55.5 acre tract. No separate value is placed on these transfers.

6. The court previously awarded the Guardians ad Litem a fee of \$125 per hour for work performed by them in this case which equates to the following:

- a.) Stephen Gooch \$4,514.53
- b.) Katherine Patton \$2,184.00
- c.) John Stanly \$1,687.50
- d.) Catherine D. O'Brien \$5,829.96
- e.) John Keene \$5215.00

7. The settlement reached by the parties hereto is a fair and appropriate use of the funds held in escrow as aforesaid.

Accordingly, it is hereby Adjudged, Ordered and Decreed as follows:

A. The plaintiffs, Della Mae Perkins, Rita Robinson, Connie Reynolds, Phyllis Miller, Jackie Perkins, Johnny Perkins, Tammy Maggard, Reba Perkins, and Shelby Perkins, and represented by Terrence Shea Cook other than as heirs and successors of Alta Perkins; and Edwards Sears, Judith Sears, Laurie Stras Thomas, Cynthia Annette Kohout, Joseph Stras, V, and Marion Stras acting through Claiborne Eldrup- Jorgenson do not have a proved interest in the gas and oil estate under the property that is the subject of this litigation. However, in compromising and quitclaiming their claims to CNX Gas Company LLC, the named plaintiffs are entitled to receive \$100,000 from the escrowed funds; Edward Sears, Judith Sears, Laurie Stras Thomas, Cynthia Annette Kohout, Joseph Stras, V, and Marion Stras acting through Claiborne Eldrup- Jorgenson are entitled to received \$180,000 from the escrowed funds; Larry Douglas Perkins, Linda Perkins Hale, Aaron Perkins, Daniel Perkins, Judy Perkins Hess, Michael Perkins, Manuel Perkins, Barbara Perkins Roman, Darrell Perkins, Frances Perkins Forbes, Katie Perkins Miller, Jeanie Perkins Howell, Ricky Allen Perkins, and Derek Perkins are entitled to receive \$100,000 from the escrowed funds; Swain Perkins is entitled to receive \$50,000 from the escrowed funds; and after payment to the Guardians ad Litem, CNX Gas Company LLC is entitled to the residue of the escrowed funds. Said payments are to be made as hereafter set forth to the attorneys representing the parties to be held in trust until distributed by said attorneys. Prior to such payment, the named parties are to execute and deliver to David Grant Altizer, Counsel for CNX Gas Company LLC, a deed in the form attached hereto to be held by him in escrow until payment is made. Thereupon, CNX Gas Company LLC will be the sole owner of the oil and gas under the 55.5 acre tract that is the subject of this litigation. Renia Perkins and Dorothy Perkins and those heirs of Joseph Stras, B. W. Stras and Augustus White who did not respond are in default and the Complaint is taken as confessed as to them.

B. Upon delivery of the aforementioned deeds to David Grant Altizer, CNX Gas Company LLC shall petition the Virginia Gas and Oil Board for fixed sum disbursements from the escrow accounts pertaining to the Units identified above and the said 55.5 acre tract as follows:

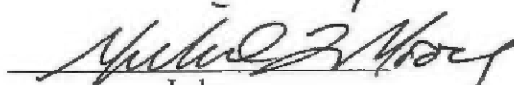
1. to Stephen Gooch, Guardian ad Litem, \$4,514.53

3. to John Stanley, Guardian ad Litem, \$1,687.50

5. to John Keene, Guardian ad Litem, \$5,215.00
6. to T. Shea Cook on behalf of the Plaintiffs, \$100,000.00
7. to T. Shea Cook on behalf of Swain Perkins, \$50,000.00
8. to Catherine D. O'Brien on behalf of the Stras and White heirs \$180,000.00
9. to John Keene, on behalf of the previously unknown heirs of Alta Perkins \$100,000.00
10. to CNX Gas Company LLC all of the remaining balances in the said escrow accounts.

In making these payments, because of the terms of the settlement, it is not necessary to require that any payment or combination of payments come from any particular escrow account(s), in whole or in part.

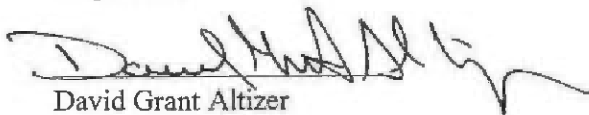
