PETITION FOR ORDER OF DISBURSEMENT OF ESCROW FUNDS

5. Factual basis for relief requested

Horne, Linkous Everett Horn, John Andrew Stilwell, Connie Ann Sparks, Patricia Kay Stilwell, Tony Douglas Stilwell, Tania Hess, Wesley D. Perkins, Martha Smith, Kathy Lynn Bostic, Frankie Lee Stacy, Chrisie Ann Smock, Melissa Kay Long & Tammy Brown have entered into royalty split agreement (s). Said royalty split agreement(s) allow the Applicant and Designated Operator to pay royalties directly to the persons identified in Exhibit EE.
- b. Martha Gulliams, Sydney Smith, Kenneth Osborne, Mary Jane Keen, Shirley Keene, Heirs of Perry W. Horn (Margaret Dye, Nellie Maynard, and Tammy Street), Paul Junior Osborne, Curtis McCoy Osborne, Barbara Joyce Harmon, & Marilyn Taylor is entitled to 100% of the CBM royalties awarded under Case No. CL10000820-00, Opinion dated October 19, 2015. Said decision allows the Applicant and Designated Operator to pay royalties directly to the person(s) identified in Exhibit EE annexed hereto and the annexed Table, further, specifies how said royalties are to be paid.
- c. That Pocahontas Gas LLC (formerly CNX Gas Company LLC) has given the notice(s) required by § 45.1-361.22:2.A to all conflicting claimants identified in the above referenced pooling Order and any supplemental Orders pertaining thereto.
- d. That when the Board granted Petitioner's Miscellaneous Petition in VGOB 98-0324-0625-11, it dismissed the coal claimant(s) Hurt McGuire Land Trust as a Respondent to these proceedings. Accordingly, Island Creek Coal Company was not provided further notice under § 45.1-361.19 and 22 of the hearing set on this Petition.
- e. That a detailed accounting in accordance with the applicable provisions of § 45.1-361.22 is submitted herewith and identified as Exhibit J.
- f. That an Exhibit identified as Table 1 is annexed hereto, and it specifies how the disbursement (s) is to be calculated and paid by the escrow agent.

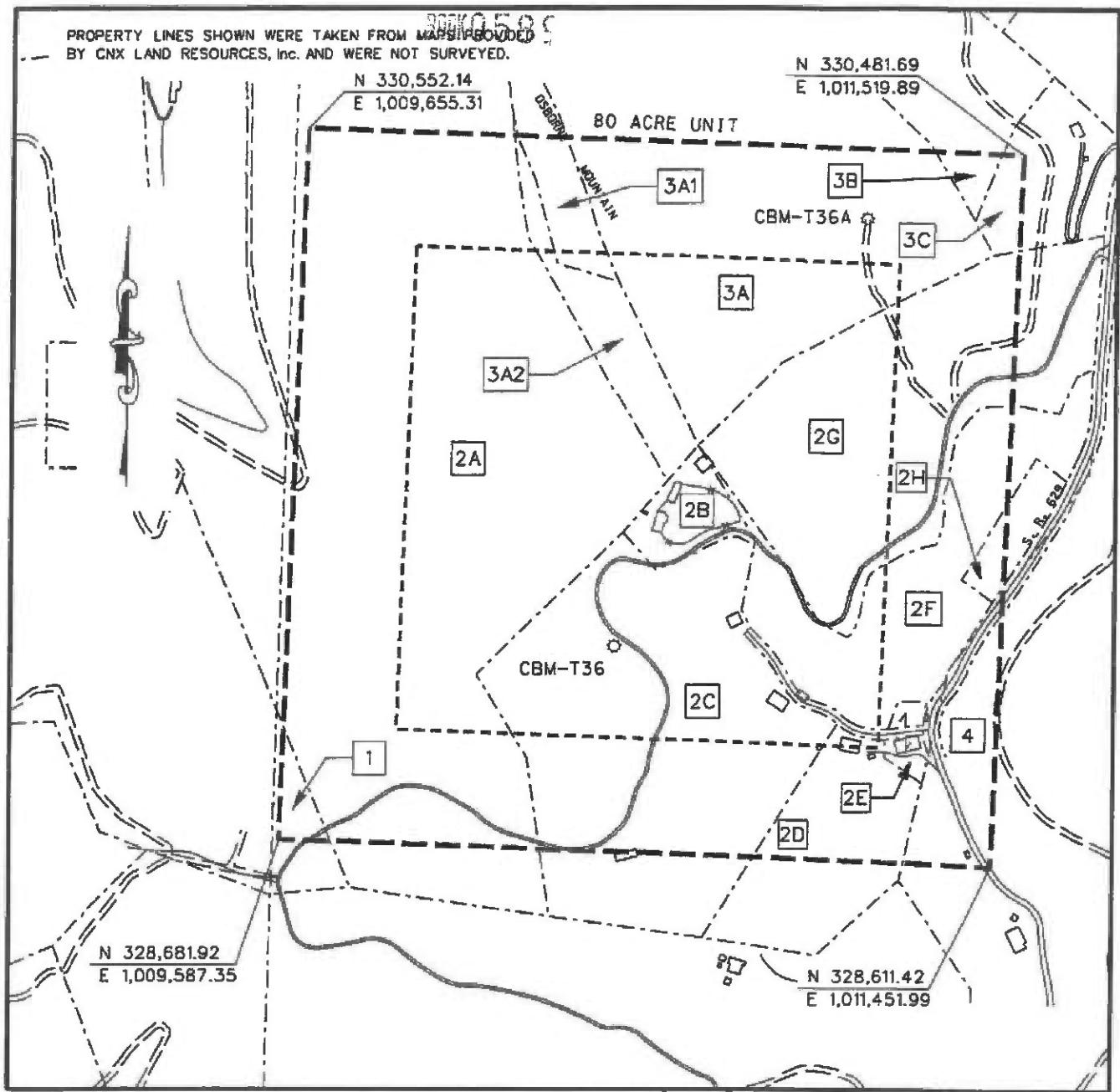
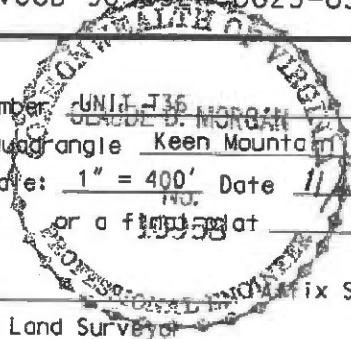

Dear Counsel:

The above-styled case is now before the Court on Plaintiff's Motion for Summary Judgment. Marilyn Horn Taylor, *et al.*, (hereinafter "Plaintiffs") commenced this Declaratory Judgment action against Danny and Jama McClanahan, (hereinafter "Defendants"), asking the Court to determine that Defendants have no ownership interest in the oil and gas estate, including coal bed methane, found on or under certain tracts of land located in Buchanan County. The parties convened for a hearing on September 8, 2015, where Mr. Mason, counsel for Plaintiffs, made an oral argument in support of his motion. Defendants presented argument in opposition to the motion. Prior to the hearing, both parties in attendance submitted memoranda to the Court in support of their respective positions, and at the conclusion of the hearing the Court granted both parties the opportunity to file an additional memorandum in support of their respective positions. After thorough review of the Court's file, evidence, and oral arguments, as well as the relevant authorities, the Court now makes the following ruling.

I. BACKGROUND

There are no material facts in dispute. In 1957, Linkous Horn and Mary Horn, of whom Plaintiffs are heirs, owned a twenty-five acre tract of land in Buchanan County. On April 13, 1957, the Horns executed a deed conveying the aforementioned property to Thurman Osborne. The deed contained the following language, "all coal and minerals are excepted in this conveyance, together with the right to mine and remove same." (Exhibit A). Subsequently, on April 30, 1946, Osborne conveyed eighteen acres of the property to Florida Keen, and the deed contained the following clause "there is hereby excepted from this conveyance such of the coal, oil, gas, minerals, rights, privileges and easements as have been heretofore sold from or excepted from said land." (Ex. B). On October 24, 1970, Keen conveyed the eighteen acre portion to Arlin and Mary Jane Osborne, and the deed contained the following clause "there is hereby excepted from this conveyance such of the coal, oil, gas, minerals, rights, privileges and easements as have been heretofore sold from or excepted from said land." (Ex. C). Then on June 1, 1984, the Osbornes conveyed the eighteen acre portion to Gary and Brenda Matney, and the deed contained the following clause "there is hereby excepted from this conveyance such of the coal, oil, gas, minerals, rights, privileges and easements as have been heretofore sold from or excepted from said land." (Ex. D). Finally, on August 12, 1988, the Matneys conveyed a nine acre portion of the eighteen acres to Defendants, and the deed contained the following clause "there is excepted and reserved from this conveyance anything and everything that may have been heretofore excepted or reserved from said land." (Ex. E).

Recently, Defendants claimed an ownership interest in any oil and gas, including coal bed methane gas, under their property. Plaintiffs ask the Court to find, through summary judgment, that Defendants have no legitimate ownership interest to the mineral rights under the relevant property. Plaintiffs base their motion on the grounds that the deeds of record, which are rightfully before the court, clearly demonstrate that there is no genuine issue as to any material fact with regard to title of the coal bed methane gas. Adversely, Defendants argue that they are the rightful owners of the mineral estate because at the time of the 1957 conveyance, the Virginia Code defined minerals as "equal ore, rock, and any other solid homogeneous crystalline chemical elements or compounds that result from the inorganic process of nature other than coal." (Com. 4). Consequently, Defendant argues, that gas, oil, and coal bed methane, have to be individually delineated to be exempted from a conveyance, and since those minerals were not delineated in his conveyance, Defendant still owns the entirety of the mineral estate.

II. SUMMARY JUDGMENT STANDARD

The Virginia Supreme Court has stated the following with regard to when a Motion for Summary Judgment should be sustained:

[s]ummary judgment upon all or any part of a claim may be granted to a party entitled to such judgment when no genuine issue of material fact remains in dispute, and the moving party is entitled to judgment as a matter of law. A grant of summary judgment must be based upon undisputed facts established by pleadings, admissions in pleadings, and admissions

made in answers to requests for admissions. Additionally, the trial court must consider inferences from the facts in the light most favorable to the non-moving party, unless the inferences are strained, forced or contrary to reason. Of course, the trial court may consider the stipulations of the parties, answers to interrogatories and deposition testimony if the parties agree. *Andrews v. Ring*, 266 Va. 311, 318, 585 S.E.2d 780 (2003).

The parties did instruct the Court that the facts were not in dispute in this case and further, given the above principles and the parties' agreement, summary judgment is an appropriate remedy if the Court sees fit.

III. APPLICABLE LAW

The dispositive question in this case is what minerals, if any, the excluding clause in the 1957 deed embraced. "Where the language of a deed clearly and unambiguously expresses the intention of the parties, no rules of construction should be used to defeat that intention. Where, however, the language is obscure and doubtful, it is frequently helpful to consider the surrounding circumstances and probable motives of the parties." *CNX Gas Company, LLC v. Rasnake*, 287 Va. 163, 166-67 (2014). Applying that principal, the Court initially confines its consideration to the four corners of the deeds to ascertain whether the language of the deeds concerning mineral rights is plain and unambiguous. The Supreme Court of Virginia has previously defined ambiguity as "the condition of admitting of two or more meanings, of being understood in more than one way." *Berry v. Klinger*, 225 Va. 201, 207 (1983).

Recently, in *Rasnake* the Supreme Court of Virginia interpreted the following excluding clause from a 1918 deed, "This sale is not meant [sic] to convey any coals or minerals. The same being sold and deeded to other parties heretofore." *CNX Gas Co. LLC v. Rasnake*, 287 Va. 163, 166 (2014). Prior to the date of the deed in question, the grantors had sold only the coal and the timber. The Court found the disputed language to be capable of being understood by reasonable persons in multiple ways, based on parties' interpretations, thus making it ambiguous and allowing for the admission of parol evidence. *Id.* at 167. After considering all possible interpretations of the conveyance, the Court applied the only possible analysis that gave effect to all the language used by the grantors and removed conflict among its parts. *Id.* "Under that interpretation, the last ten words modify the preceding sentence, denoting the grantors' intent to exclude from the conveyance only those mineral rights previously conveyed to others, namely the coal." *Id.* at 169. Thus, the deed conveyed all mineral rights to the grantee except for the rights to coal and timber, which had previously been conveyed to a third party.

In another relevant case, *Clinchfield*, the Virginia Supreme Court interpreted the following conveyance "all the coal and minerals of every description in, upon, or underlying' the lands herein involved." *Warren v. Clinchfield*, 166 Va. 524, 526 (1936). In that case the Court found, that "taking the deed "by its four corners," there is no doubt that the language thereof clearly indicates a conveyance, not only of coal, but of "all other minerals of every description." *Id.* at 527. "The question then narrows down to this proposition: Are petroleum, oil and gas minerals? The Court found that "unless it appears that the term was used in a more restricted sense, the term 'mineral' ordinarily embraces oil or petroleum, and natural gas; and has

also been held to embrace water." *Id.* (emphasis added). In reaching this conclusion, the Court defined minerals as "all the substances in the earth's crust which are sought for and removed by man for the substance itself. It is not limited to metallic substances, and even petroleum and natural gas have been held to be minerals." *Id.*

Although, these two decisions seem contrarian, they represent the difference between an ambiguous reservation, capable of multiple interpretations, and an unambiguous reservation. The distinguishing factor between the two being that the former included the clause, "the same being sold and deeded to other parties heretofore," which, after giving effect to all of the language employed by the grantors and eliminate conflict among its parts, the Court found created an ambiguity. Had the deed simply stated that "this sale is not meant [sic] to convey any coals or minerals" the Court would have found the reservation to be unambiguous and awarded ownership of the mineral estate to the grantor, as evident by the Court's decision in *Clinchfield*. Instead, after finding the deed ambiguous the Court used various rules of construction to resolve the ambiguity against the grantor, and awarded ownership of the mineral estate, sans coal and timber, to the grantee.

IV. ANALYSIS

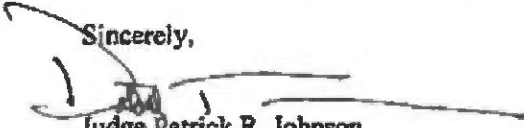
The germane reservation from the 1957 deed states that "All coal and minerals are excepted in the conveyance, together with the right to mine and remove the same." (Exhibit A). Unlike the *Rasnake* deed, this deed does not contain a modifying clause, and is instead more analogous to the *Clinchfield* deed. Consequently, taking the deed "by its four corners," there is no doubt that the language thereof unambiguously indicates a conveyance, not only of coal, but of all minerals. Lastly, the deed does not contain any terminology restricting the ordinary meaning of mineral, and as such the mineral reservation embraces the rights to all minerals, even though they have not been specifically delineated.

V. CONCLUSION

The Court relies on *Rasnake* in holding that there is no genuine issue of material fact before the Court at this time. The sole issue presently before the Court is the application of law to the language of the relevant deed. As such, after drawing all reasonable inferences in favor of Defendants, it appears to the Court that Plaintiffs is entitled to a summary judgment. Defendants have no interest in and to any oil and gas interest, including coal bed methane, with respect to the property conveyed to them by deed dated the 12th day of August, 1988.

Mr. Mason is directed to prepare an Order reflecting the findings of this Court and to forward the same to Defendants for endorsement and then the Court for entry.
