MISCELLANEOUS PETITION

1. **Parties:** Applicant is **Pocahontas Gas LLC**, 1825 Front St, Suite 104, Richlands, Virginia 24641. Respondents are listed on Exhibits "B" and "B-2" attached hereto and made a part hereof. Set forth in Exhibits "B" and "B-2" are the names and last-known addresses of each owner of record identified by the Applicant as having or claiming an interest in the coalbed methane gas underlying the drilling unit known as Buchanan No.1 VS-18. Exhibit B-2 lists the Respondents that are owners and/or claimants in the proposed unit Buchanan No 1 South 2 Panel SGU sought to be created by the Application filed in Docket No. 26-0721-4330. Exhibit B lists the owners and claimants pooled who will have acreage remaining in the VS-18 Unit if this Petition is approved. Each of the individuals named in Exhibits "B" and "B-2" if living, is made a party hereto. If any such individual is deceased, then the known and unknown heirs, executors, administrators, devisees, trustees and assigns, both immediate and remote, of any such deceased individual are made parties hereto. Each of the legal entities named in Exhibit "B", if such entity continues to have legal existence, is made a party hereto. If any such legal entity is dissolved, then the known and unknown successors, trustees, and assigns, both immediate and remote, of such entity are made parties hereto.

2. **Facts:**

- a. If the Application in Docket No. 26-0721-4330 is approved, some of the Respondents listed in the Exhibit B filed in re Docket No. 23-1121-4277-01 will have their acreage transferred in whole or in part to the Sealed Gob Unit created by Docket No. 26-0721-4330. See Petition and Exhibits filed in re Docket No. 26-0721-4330 which are incorporated herein by reference. The Respondents listed in Revised Exhibit B hereto will continue to have interest in the VS-18 Unit as modified therein.
- b. The undersigned certifies that the matters set forth in this application, to the best of her knowledge, information and belief, are true and correct.
- c. The sealed gob drilling unit sought to be created by the Application filed in Docket No. 26-0721-4330 is entirely within the boundaries of the BUCHANAN NO.1 VS-18 Unit created and pooled by the Board Order entered on the 24th day of June 2024 in Docket No. VGOB-23-1121-4277, and modified by Order entered on the 21st day of April 2025 in Docket No. VGOB 23-1121-4277-01.
- d. This Application seeks to modify the Board's Order creating and pooling the BUCHANAN NO.1 VS-18 Unit by (1) extracting the acreage within the unit to be known as Buchanan No.1 South 2 Panel SGU unit from the acreage that is currently within the BUCHANAN NO.1 VS-18 Unit and (2) extracting the **42.62** acres contained within the solid coal block remaining between Buchanan No. 1 South 1 Panel SGU and the proposed Buchanan No. 2 South 2 Panel SGU and (3) to modify the VS-18 division of royalty interest percentages of the royalty owners and/or claimants with acreage remaining in VS-18 accordingly. Attached hereto is a revised Exhibit B for the acreage which will remain in the BUCHANAN NO.1 VS-18 Unit.
- e. Simultaneously with filing of this application pursuant to Va. Code Ann. § 45.2-1622.A. Applicant is providing notice by certified mail, return receipt requested to each person named as an Owner/Claimant in the Exhibit B having or claiming an interest in the coalbed methane gas, underlying the Subject Lands pooled herein. Applicant hereby notifies the board that where the identity or location of any person is shown as "unknown" on Exhibit "B", then Applicant is unable to provide said person with written notice of the application herein by mail.

3. **Legal Authority:** Va. Code Ann. § 45.2-1600, *et seq.* 4 VAC 25-160-140 and such other regulations promulgated pursuant to law as may pertain hereto.
4. **Relief Sought:** Applicant requests the Board issue an order providing as follows:
 - a. Extracting the acreage within a sealed drilling unit consisting of 310.15 +/- acres from the VS-18 Drilling Unit. The acreage to be extracted is described and depicted in Exhibit "A" annexed hereto and is bounded as follows: Beginning at a point, Virginia State Plane NAD 83 coordinate of N: 3593789.80 E: 10487142.57 (southwest corner of Buchanan Mine #1 Sealed Gob Unit South 2 Panel); thence S 88°48'13" E 1424.74 feet to a point, Virginia State Plane NAD 83 coordinate of N: 3593760.05 E: 10488567.00 (southeast corner of Buchanan Mine #1 Sealed Gob Unit South 2 Panel); thence N 18°05'19" W 266.16 feet to a point, Virginia State Plane NAD 83 coordinate of N: 3594013.05 E: 10488484.36; thence N: 01°37'37" E 9566.63 feet to a point, Virginia State Plane NAD 83 coordinate of N: 3603575.83 E: 10488755.98; thence N: 18°34'10" E 134.18 feet to a point, Virginia State Plane NAD 83 coordinate of N: 3603703.03 E: 10488798.71; thence S: 86°41'59" E 96.77 feet to a point, Virginia State Plane NAD 83 coordinate of N: 3603697.46 E: 10488895.32 (northeast corner of Buchanan Mine #1 Sealed Gob Unit South 2 Panel); thence N 88°22'44" W 1446.87 feet to a point, Virginia State Plane NAD 83 coordinate of N: 3603890.36 E: 10487449.01 (northwest corner of Buchanan Mine #1 Sealed Gob Unit South 2 Panel); thence S: 39°28'40" W 31.53 feet to a point, Virginia State Plane NAD 83 coordinate of N: 3603866.02 E: 10487428.96; thence S 01°37'41" W 10080.29 feet a point of beginning, containing +/- **310.15** acres.
 - b. Re-establishing the percentages for division of interest for production, revenue and costs in accordance with those percentages as are set forth at Revised Exhibit "B" hereto.
 - c. Granting such other relief as is merited by the evidence and is just and equitable, whether or not such relief has been specifically requested herein.

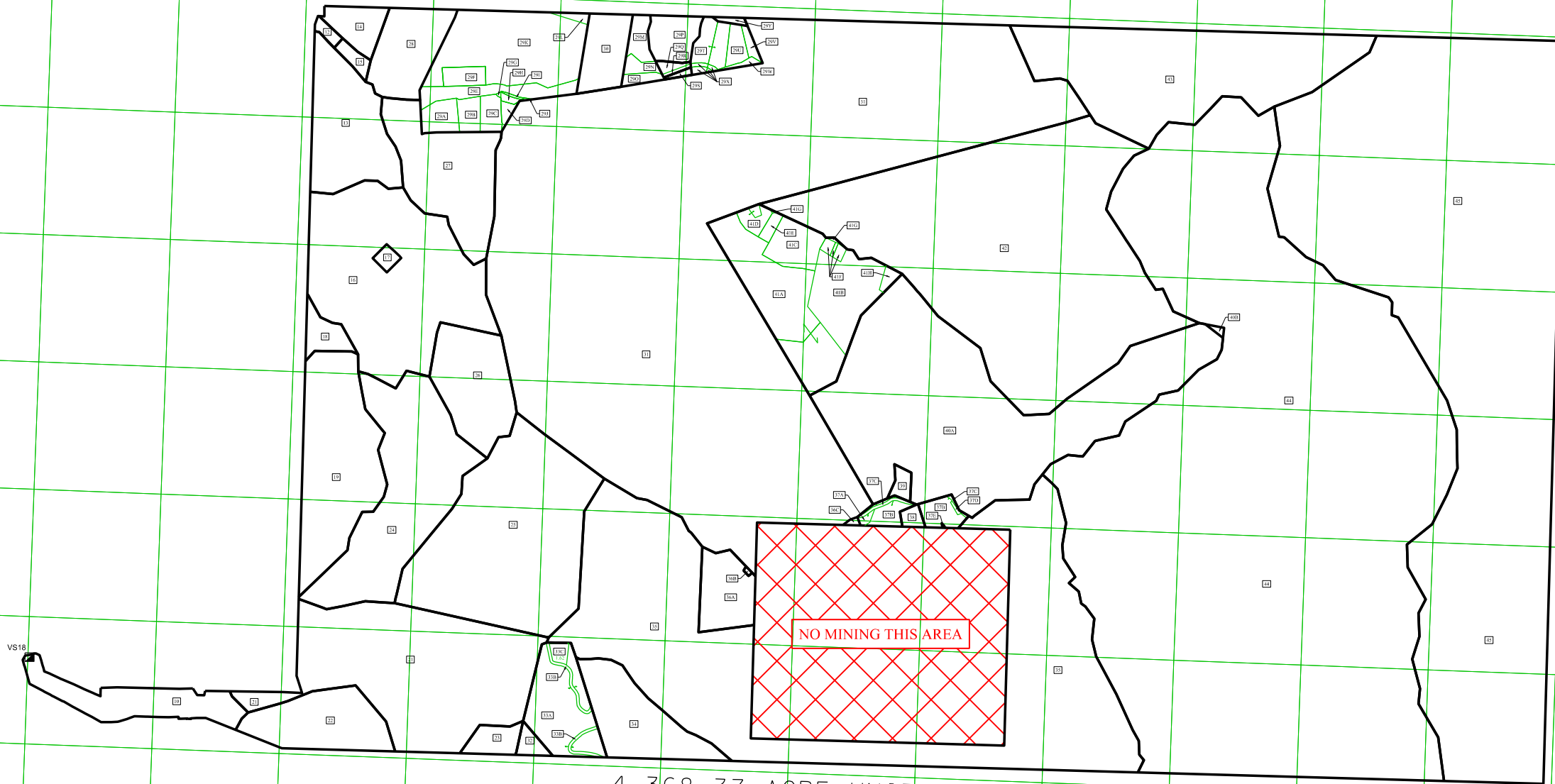

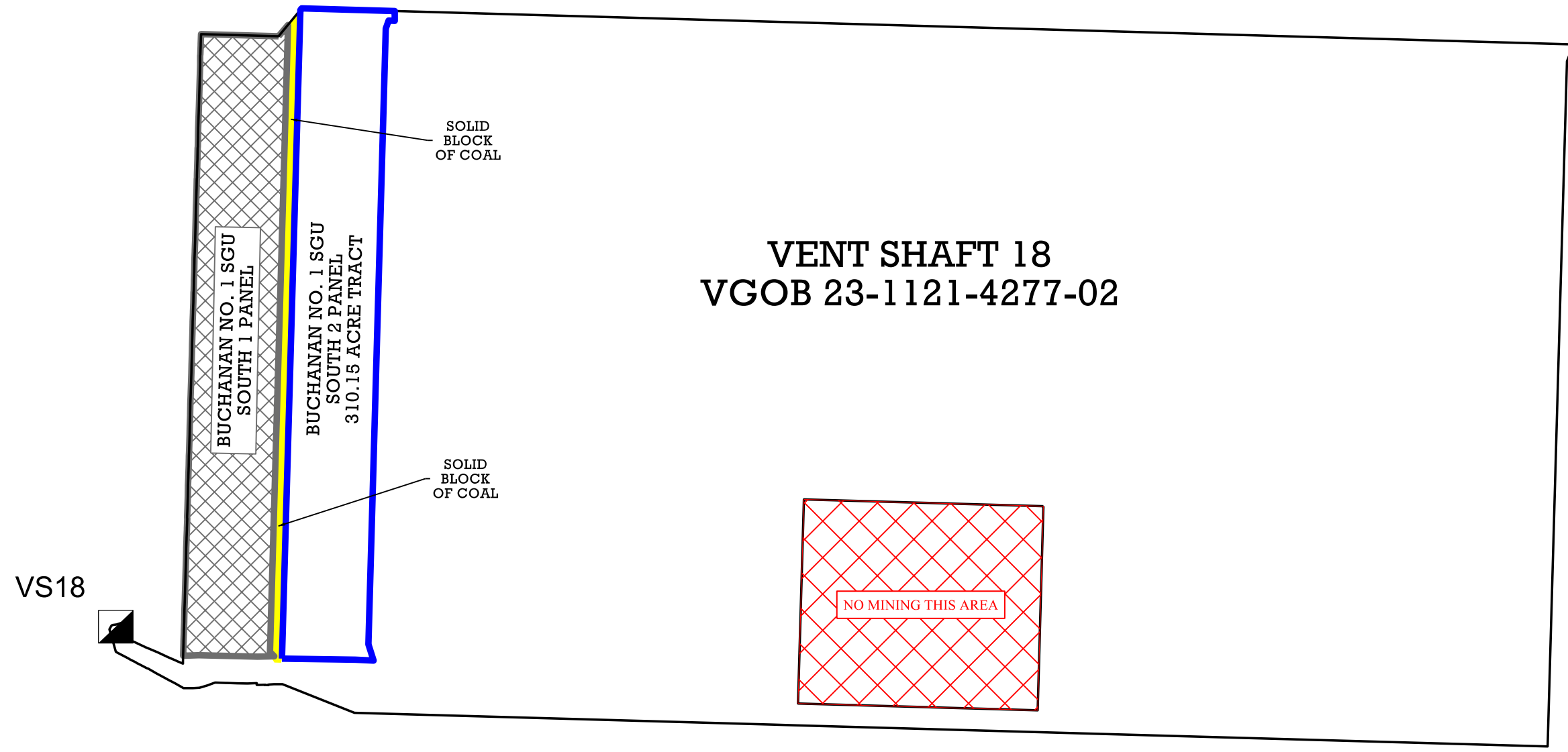

REPORT OF THE BOARD

FINDINGS AND ORDER

6.1 Applicant requests that the Board extract the acreage within the Buchanan No. 1 South 2 Panel SGU consisting of **310.15 acres**, from the Buchanan No. 1 VS-18 Unit. The boundaries of the acreage to be extracted are depicted in Exhibit A hereto which unit and acreage are bounded as follows:

Panel); thence S 88°48'13" E 1424.74 feet to a point, Virginia State Plane NAD 83 coordinate of N: 3593760.05 E: 10488567.00 (southeast corner of Buchanan Mine #1 Sealed Gob Unit South 2 Panel); thence N 18°05'19" W 266.16 feet to a point, Virginia State Plane NAD 83 coordinate of N: 3594013.05 E: 10488484.36; thence N: 01°37'37" E 9566.63 feet to a point, Virginia State Plane NAD 83 coordinate of N: 3603575.83 E: 10488755.98; thence N: 18°34'10" E 134.18 feet to a point, Virginia State Plane NAD 83 coordinate of N: 3603703.03 E: 10488798.71; thence S: 86°41'59" E 96.77 feet to a point, Virginia State Plane NAD 83 coordinate of N: 3603697.46 E: 10488895.32 (northeast corner of Buchanan Mine #1 Sealed Gob Unit South 2 Panel); thence N 88°22'44" W 1446.87 feet to a point, Virginia State Plane NAD 83 coordinate of N: 3603890.36 E: 10487449.01 (northwest corner of Buchanan Mine #1 Sealed Gob Unit South 2 Panel); thence S: 39°28'40" W 31.53 feet to a point, Virginia State Plane NAD 83 coordinate of N: 3603866.02 E: 10487428.96; thence S 01°37'41" W 10080.29 feet a point of beginning, containing +/- **310.15** acres.

6.2 That the Board re-establish the percentages for division of interest for production, revenue, and costs for all Respondents with acreage remaining in the Buchanan No. 1 VS-18 Unit in accordance with those percentages set forth in Revised Exhibit B to the Application.

7. Relief Granted: The requested relief in this cause shall be and hereby is granted and:

7.1 The relief requested and granted is just and reasonable, is supported by substantial evidence and will afford each person listed and named in **Revised Exhibit B** hereto the opportunity to recover or receive, without unnecessary expense, such person's just and fair share of the production from the Subject Unit. The granting of the Application and relief requested therein will ensure to the extent possible the greatest ultimate recovery of Coalbed Methane Gas, prevent or assist in preventing the various types of waste prohibited by statute and protect or assist in protecting the correlative rights of all persons in the subject common sources of supply in the Subject Lands. Therefore, the Board is entering an Order granting the relief herein set forth.

8. Mailing Of Order And Filing Of Affidavit: Applicant or its Attorney shall file an affidavit with the Secretary of the Board within sixty (60) days after the date of recording of this Order stating that a true and correct copy of said Order was mailed within seven (7) days from the date of its receipt by Unit Operator to each Respondent named in **Revised Exhibit B** included with this Order and whose address is known.

9. Availability of Unit Records: The Director shall provide all persons not subject to a lease with reasonable access to all records for Subject Unit which are submitted by the Unit Operator to said Director and/or his Inspector(s).

10. Conclusion: Therefore, the requested relief and all terms and provisions set forth above be and hereby are granted and IT IS SO ORDERED.

11. Appeals: Appeals of this Order are governed by the provisions of Va. Code Ann. § 45.2-1625 which provides that any order or decision of the Board may be appealed to the appropriate circuit court.

12. Effective Date: This Order shall be effective as of the date of the Board's approval of this Application, which is set forth at Paragraph 1 above.
