## Harrisonburg Receives SolSmart Bronze Designation for Advancing Solar Energy Growth

The City of Harrisonburg Now Well Positioned for Solar Development

**Harrisonburg, Va.** –The City of Harrisonburg received a Bronze designation from the national <u>SolSmart</u> program for making it faster, easier and more affordable for homes and businesses to go solar. The Virginia Department of Energy (Virginia Energy) partners with the University of Virginia's Weldon Cooper Center for Public Service to serve as a no-cost technical advisors with the program.

"Congratulations to the city of Harrisonburg for seeing a future in solar development and for taking advantage of the Solsmart program. Our agency is proud to partner with localities interested in welcoming and helping develop this renewable energy industry," **said Virginia Energy Director John Warren**. "Deploying solar can also lead to job growth as many businesses are looking for clean energy opportunities here in the Commonwealth."

The City of Harrisonburg's new SolSmart Bronze designation recognizes Harrisonburg for taking bold steps to encourage solar energy growth and remove obstacles to solar development. For companies looking to expand, a SolSmart Bronze designation is a signal that Harrisonburg is "open for solar business."

"SolSmart designation is a great step forward for the city," said **Harrisonburg Public Works Sustainability and Environmental Manager Keith Thomas**. "We are working to reduce barriers and provide access to information so more of our residents and businesses can explore their options to go solar."
